## A seni March 9, 2021, ewe anapenon annukun momon muunap ngeni aramas meinisin a kan titifocho. Ese chuen no apechakuneno non ew neni non ewe United States. Wewen ei pwe:

- Chon etto ikei ra tongeni tumun ne angei aninisin aramas meinisin, mongoeoch me pwan aninisin imweimw kena.
- Ekkei aninis repwene ngaw ngeni ususun ar etto ikei.

## Won September 8, 2022, ewe U.S. Department of Homeland Security a atowowu ew minafon annuk ina a kan forsefani ewe weweiti ren "momo ngeni meinisin" ina a katonong non seni 1999.

Ewe minafon annuk epwene aeoeo ngeni meinisin aeoeon etto ikei ra file won ika murin December 23, 2022. Non ei fansoun, U.S. Citizenship me pwan etto ikei Services (U.S. Citizenship and Immigration Services, USCIS) epwene tapwei an President Biden we [Executive Order 14012](#) me pwan foforngeni ekkewe annukun momo ngeni meinisin ina ra forita non ewe [1999 Interim Field Guidance](#).

Ewe 1999 annukun momo ngeni meinisin iei a aeoeo ngeni, nge chechemeni pwe:

- Chomong ekkena ir resapw chon ikei kena ra kan eimuno seni ewe annukun momo ngeni meinisin.
- Napenon ekken ir resapw chon ikei kena ir ra kan naf ren aninisin meinisin eimuno seni ewe annukun momo ngeni meinisin.
- Napenon ekkena aninis noun emon esap chon ikei semirit kewe ra kan angei ika pwan ekkoch chon an family kena **rese kan** anea nupwen an ewe chon etto ikei we tesin fofor ngeni meinisin non ewe US.

## Ewe annukun momo ngeni aramas meinisin ese kanaeoeo ngeni napenon aramas meinisin ina ir ra naf ren aninisin aramas meinisin.

Ekkoch ekkena ir resapw chon ikei ra ka eimuwow seni ewe annukun momo ngeni meinisin, mi pachenon nge esapw awukuk ngen:

- Chon aeoeo kena ra kuut ususun chon suseni moun ika tumun seni afeiengaw.
- Chon nonomfochenon U.S. kena mi pachenong ekkena ra asofosefani nour green card.
- Ekkena ir esapw ir chon ikei ra kuuta ususun T (chon feiengaw seni asaifetanen aramas) ika U (chon feiengaw seni foforon katan annuk).
- Aeoeon kuuten Temporary Protected Status (TPS);

lei, ewe annukun momo ngeni meinisin a chok ekeki ren eaeen ekkei programen:

- Mwochomwochen Aninisin ren Family non Osupwang ((Temporary Assistance for Needy Families, TANF), ew aninisin moni iteiten maram);
- Pwan ekkoch state, Mwichen Indian, territorial, ika programen aninis moni non neniach kena ("Unusen Aninis");
- Supplemental Security Income (SSI); me pwan
- Programen muun kena ra aninis aramas kena ra nom non nenien longetamen tumun kena, usun chok ew nursing home ika nenien semwenin non mokur.

## Efen programen aninisin aramas meinisin ese kananea pwe momo ngeni meinisin?

  - Meinisin pwan ekkena ekkoch aramas nap (awewe, Medicaid me pwan Healthier Oregon)
- Pwonupwonun safean anounou
- Oregon MothersCare program
- Supplemental Nutrition Assistance Program (SNAP) ika food stamp kena mi pachenong Pandemic EBT
- Imweimwen Aramas meinisin me pwan asopwesopwen momon imweimwen Section 8
- Section 8 aninisin rent (awewe, voucher kena ren finin imweimw)
- Women, Infants and Children (WIC) (Aninisin amongoeoch ren fefin, menukon kena, me pwan semirit kena epwe tori ier 5)
- Tesin COVID-19, tumun, me pwan appos
- Mongo seni ewe bankin mongo ika pworen

  - Awasano Form I-864 (Taropwen Aninisin), a file fan iten ewe esapw ii chon ikei, me pwan
  - Risiten aninisin moni seni nom ika iei me pwan momo seni muun ren tumunun nongetamen tumun.
