Won Fapuwari 18, 2022, Oregon a atouranong echo 2022-2027 1115(a) apinikeisen fan iten ewe Demonstration Waiver epwe renew ngeni ewe Centers ren Medicare me Aninnisin Medicaid (CMS). An Oregon ewe apinikeisen epwe sopweno ewe acheon angang ren ewe Oregon Health Plan (OHP) non ar kutta ar repwe eponuwa ekkewe angang ese nonnopok ren aninnisin health non ach ei state, fengen me achocho ne sopweno ar aninnis ngeni aramas ren nour insurance me angangen otufich pwe repwe atoura ekkewe aninnis mei murinno, non an epwe naaf niwinin ngeni aramas.

COVID-19 mei pwarano anonnonun ekkewe angangangaw a minen nomw, mei fokkun cheufetan non ach nenien aninnisin health me neniach ei. Kich mei nuku pwe ika si oturau ekkei angang mei ngaw ren an ese nonnopok ngeni aramas, fengen me awora ennuhun ei napanap non ach ei state, iwe epwe mhuut ngeni kich fansoun an aramasen non ach community ir mei tufichingaw ren osupwang pokiten ir chon ekis, repwe pochokkun sefan me chikar seni semwen.¹ OHA mei fori ar angang an epwe tufich an ei state prokrammin Medicaid nesor me peonon, mei fofforuta seni met ra sinei pwe mei wor tufichin me chemeni mwirimwirin met si kuna fansoun ei COVID-19.

Pworousan

An Oregon ewe 1115(a) Demonstration e popwuta non 1994 me a soun renew me eochuno seni non ena fansoun. Ewe 2012 renew e popwutani ewe angangechu ren tumwun organization (CCO), minne-ka mei awora tumwun ngeni chon nounou Medicaid ren ar fori angangen ainnis ar repwe epwungu ekkewe osukosuk e feito seni angangangaw me nifinifin non ach system ren health.

Ekkewe CCO mei pwisin wor kookun ar pwachet iteiten maram ren aninnisin tumwun ren inis, netip, me non aaw fengen me mei pwan tongeni anisi nour aramas ar repwe safei me nukun met aninnis re awora. Ei pwachet mei pwan awora niwininir ika nour aramas ra chikar seni ar

Non 2016 Oregon mei awatteno ar angang ar ewe renew sefan, ren ar ekieta koukun ar mwoni tou ren ewe Health-Related Services (HRS) fan iten kutten met sokkun osukosuk aramas re nonnomw non nge repwe fetan ngeni semwen, me mwuutata ekkewe CCO ar repwe awora aninnisin epochokkunen health.

Me nukun an Oregon tufichin aninnis ren tumwun, Oregon epwe chok pwan achocho ne anisi ekkewe aramas re tufichingaw ren an ese nonnopok aninnisin health ngenir non Oregon. Chon aea ewe Oregon Health Plan me chiechiar mei soun esinesin pwe re mochen OHA epwe fori angangen ar repwe eponuwa ekkewe angangangaw me non ei health system *me* ar community, ian re nonnomw me angang ie.

Awateno aninis epwe kawor epwe chok sopwosopwono me nonnopok

An Oregon ewe tettennin kapas eis fan iten health a affata pwe, nefiinen 2019 me 2021, chon nounou insurance non ei state mei kekiita seni 94% ngeni 95.6%, iei wattenon me non unusen ar sinei. Pwan ew, ekkewe chon Mei Chonochon non Oregon re nounou insurance mei kekiita seni 92% ngeni 95%. Ei siiwin e feito seni an sopwosopwono noun aramas insurance ren Medicaid fansoun an public health imerechensi ren COVID-19—a ffat pwe mei auchea ei Medicaid prokram an epwe ekisatiw osukosuk me eochueno angangen nonnopok ren aninnisin health.

Pwokiten an sopwosopwono me nonnopok aninnisin pekin health insurance, mei tour ngeni aramas ekkewe aninnis me auchea ngenir. Ekkewe aramas mei kono enuwen inisir me ach kewe community re tufichingaw pokiten kopwut, ir mei chommong rese nounou insurance. Ewe angangen renew mei apachanong an epwe sopwosowono noun aramas insurance non ukuukun ruu-ier, nimwu-ier ren semirit tori an a 6 ierir; me chommongono aninnis ngeni aramas non Oregon e popwuta ne wor siiwin non manawar.

Non ekkei ran mwan, OHA mei achocho ne fori angangen an epwe tour ngeni aramas aninnis, ekkewe re nounou OHP minne-ka, nupwen an a wes ei public health imerechensi, rese chiwen tufichin nounou nour OHP.

Epochokkunen an aramas health ren kokkotun manaw me ekkesiwinin nour insurance

Met sia sinei nge mei kouno noun aramas insurance me an epwe tour ngenir aninnisin tumwun fansoun a wor siiwin ren nonnomwur me ar mwokutukut non ekkei system, aweve ren ika ra mwuusou me non kanopwuus ika me non an state pioing. Mei osukosuka fansoun an epwe tour ngeni aramas aninnis mei auchea ren semwenin netip me semwenin inis fansoun ekkei siiwin, minne-ka mei efeiengaw ngeni aramas me ngeni ekkei system. Pwan ew, ekkei sokkun osukosuk e konnien fisi ngeni aramas mei kono enuwen inisir fengen me ina popwun ese wor nonnopok ren aninnisin health. An epwe komwochuno won me sopweno ach tufich, Oregon epwe sopweno ne fori ew angangen kameti epwe awora niffangen kame ren anonnopokun aninnisin health, anen an epwe eochuno an aramas health me epochokkuna nonnowun aramas re nounou Medicaid me CHIP, nge resapw nounou mwoni ren niwinin safei me aninnis chok.

Ewe agnangechu ren tumwun e fofforuta an epwe awora niffangen anganeoch me kawor. Non ekkei engon ier sia tou seni, Oregon a kuna pwe mei wor tufichin ar awora niffangen anganeoch. Non an wor niwinin anganeoch ren an epwe wor niffangen murinno, mei chiwen chommong fansoun an ese nonnopok anganeoch ngeni aramas.

OHA mei mochen fori ekkesiwinin met ewe re nennengeni, ar repwe nengeni met kewe mei eoch me kaworan nge pwan ew minafo mwokutukut ren angangen nonnopok ren an epwe wor pochokkun, Oregon epwe pwan achocho ne eochueno ar angang pwe epwe nonnopok porousen nonnomwur aramas.

Ei system epwe pwan fori angangen non ar community ar repwe katon met e fis ngeni aramas an esapw nonnopok tumwunun health ngenir. An epwe wor ponuwen ewe angangen health ese nonnopok, Oregon epwe mwuut ngeni ekkewe community re tufichingaw fansoun ar repwe finata met epwe fis, an epwe wor ar pochokkun me pisek.

Ei state mei tongor ren met aninnis epwe nonnopok me eineti sefanni ekkewe mwonien aninnis me pwan ekkewe pochokkunen finata kokkot me non ekkewe community. An epwe tongeni wor aninnis an ekkewe community repwe fori angangen an epwe nonnopok aninnis me an epwe fofforuta ew auchean infrastructure ren porous me mwoni tonong ren ekkewe organization re awora ekkei sokkun aninnis, Oregon mei tongor an ewe CMS epwe mwuutata ketiwen mwonien federal (FFP) an epwe no ngeni ekkewe prokrammin state health (DSHP).

Oregon ese ara pwe repwe nounou mwonien DSHP ren an epwe no ngeni unusen ewe prokrammin Medicaid ika ren an epwe sopwengeni ar pwachet ika ese naaf. Nge, ei state epwe pwoputani ew minafo, state-chok mwoni tonong ren health seni ewe Legislature non ekkewe ier sia tou seni epwe tufich ngeni DSHP, me pwan ekkewe minafo pisek an federal epwe no ngeni ekkewe community mei nomw non osupwang seni nomw, pwe epwe anisir an ese nonnopok aninnisin health ngenir.

An Oregon nenengeni ekkewe mwoni tonong non ar community fan iten anonnopokun aninnisin health, epwe eochuno met kewe mei eppet i aninnis ren pekin health, eukatiw niwinin me awora nonnopok ren aninnisin health ika ei tingor mei ketiw.

Ewe kokkot mei feito seni metewe pworous mei fatefateoch seni ekkewe community, chon pwopworous, epwe organization ren aninisin semirit, me pwan ekkoch mwiih ir mei mochen aninis non ewe angang. Oregon epwe sopweno ne anonga an ekkewe OHP aninnis won ewe Tettennin Aninnis ren Pekin Health Epwe Akkomw, iwe nge, ewe state epwe fori pwe, me awora ngeni semirit, meinisin sokkun aninnisin pekin safei mei auchea epwe ketiw ren safeian ar semwen e pwaano ren ewe angangen EPSDT.
