2. ADA eo ej bōjrak ri kōjermal ro jān aer kalijekļok armej jān jikin jermal kōn unin ājmour ak aenōmman ijellokun wōt ñe rej “lukkuun kōuwōtata” (āinwōt ñe armej emaroñ bōk jorrāān eo enana meñe ej bōk jipaņ).
