### **1. Edomw pwon oh pil edomw ke mwahuki**

Edomw pwon iei ehd me Social Security Administration kin doadoahngki de ehd me Social Security Administration ale sang aplikeisin teieu. Ehd pwon en wehi pil kak kasehda pohn doaropwe en mih nan wehi kan, doaropwe en ihs kowe me kohsang koapwaorment, oh rekord en neitik kan.

Se kin doadoangki wasahn nekidala ire en electronic kan pwehn tehk ma ire kan ke kihda pwung de sapwung. Se kin doadoangki edomw pwon ni aht doadoangki wasahn nekidala ire pwukat. Ke kak wadek duwen wasahn nekidala ire pwukat nan pali en “Wadek oh Sain” nan the 11.

Edomw pwon iei ehd me se pahn doadoahngki ni aht kadarawei kisin likou kan.

Edomw me ke mwahuki iei ehd me se pahn doadoangki ni ahmw koasoihengkiht. Se sohte pahn doadoangki ehd wet nan doaropwe kan.

### **3. Aramas dah men kowe**

### **4. Ma ke peki pein kowe ale kamwahu kan, mie ahmw nempe en Social Security (SSN)?**

Aramas koaros me ahniki SSN oh peki sawas en pwain wini anahne kaselehda arail nempe. Ma ke peki sawas nan ahmw aplikeisin oh sohte ahmw SSN, ndaiongkiht dahme ke sohte ahnikiki SSN ieu. Ma ke mwahuki sawas en peki ale SSN ieu, kahlhkiht ni 1-800-699-9075.

Tohnihmw kan me sohte peki sawas en pwain wini sohte anahne kaselehda ma mie arail SSN de dahme re sohte ahnikiki SSN ieu. Ahpw, mwomwen kanekehla aplikeisin pahn mararahda ma re kaselehda arail SSN kan. Se doadoangki ahmw SSN pwehn tehk ma ire kan ke kaselehiongkiht pwung de sapwung, iangahki uwen kapidolong ke kin ale.

### **5. Email**

### **8. Ia wasa imomw**

Menlau kaselehda ia wasa imwomw, ma mie imwomw. Pil kaselehda ahmw ZIP code. Se anahne ZIP code pwehn tehk mwahu me ke ale soang en sawas kan me mie nan ahmw wehi.

Ma sohte imwomw, menlau kaselehda county, state, oh ZIP code me ke kin mihmi pak tohto.

### **9. Ia wasa imomw**

Menlau kaselehda wasa me se kak kadarala doaropwe kan ma:

- Sohte imwomw; de
- Mie ahmw mehn pwunod kan pid sihr, including uk nan pwungen pwopwoud.

**12. Ke mwahuki pilada aramas me nainiki mweimwei en wiliankomwihdi oh irail me pil kak pwainda?**

Sounwyliepe men kak wia soang kan duwehte kanekehla aplikeisin kan de leleki wekid kan.

Pil emen me kak pwain iei aramas de pwihn me pil kak wilianuhkidi ale kamwahu kan. Aramas oh pwihn pwukat doadoangki ahmw kamwahu kan ni ansou me ke sohte kak de sohte mwahuki doadoangki. Irail sohte kak doadoangki kamwahu pwukat pwehn sewese pein irail. Soang en kamwahu kan me re kak wilianuhkidi iangahki isais pwehn wiahda mehn pidolong nan ihmw nan wheelchair.

**14-15. Kalelepak kan pid pwain daksis**

**17. Sawas en wini ni mahso**

Ma ke anahne sawas en pwain wini me wiawi nan soupwong siluh samwalahro, menlau ndaiongiht. Se pahn pilada ma sawas en wini pwukat kak iang ale sawas en pwain. Se pahn kdarawei pakair ieu ma re kak iang ale sawas en pwain. Ma ehi, ke kak ndaiong pwihn me seweseiuhk en kdaralahng OHP uwen mwoni re anahne pwainda.

**18. Pirokiram kan me koasoandi aramas me sounpar ieu, masukun, de pakolong**

Ni ahmw peki ale sawas en wini, se tehk soang en pirokiram dah ke kak iang towehda. Ekei pirokiram kan koasoandi sewese aramas nin duwen sounpar de ma re masukun de pakolong. Ma se leme ke kak iang soang en pirokiram pwukat, se pahn kdarawei kisin likou ieu pwehn wiahda ansou en koasoaipene. Ire kan me se pahn anahne mih nan **Koakondakong A.**

**25. Mie ahmw soang en mweimwei en mihmi wehi wet pah?**

Se doadoangki ire pwukat pwehn wehwehki uwen kamwahu kan ke kak ale.

Pid kalelepak kan b-g, se kak doadoangki sapeng kan pwehn tehk ire kan ke kihda pid ahmw mweimwei en mih nan wehi. Ke sohte anahne sapeng kalelepak pwukat ni ahmw kanekehla aplikeisin, ahpw e kak kamarahrahdha ansou en iang pirokiram.

## **PALI 2 — Tohnihmw Teikan**

Nan **Pali 2**, se peki kalelepak oulap kan pid tohnihmwomw teikan. Pwehn wehwehki dahme se kin peki rehn aramas keimen, menlau kilang pali teio nan *Oaralap en Aplikeisin* wet.

**4. Ia mwomwen ke peneineiki tohnihmwomw 2 (aramas keimen)**

Se anahne ia mwomwen ke peneineiki aramas keimen. Soang en peneinei iangahki: pahpa de nohno, sounsilasil, seri, pirien, pahpa de nohno laud, ape. Ma ke sohte peneineiki, ke kak ntingidi “sohte peneineiki.”

**5. Ma ke sohte en Aramas 2 ah pahpa de nohno, kowe ah sounsilasil men?**

Sounsilasil iei emen me peneineiki seri oh ahniki pwukoa laud en apwalih serio.

Ke sohte anahne sapeng kalelepak wet ma aramas keimen iei en seri ah pahpa de nohno. Ke shote anahne sapeng kalelepak wet ma Aramas 2 sounpar 19 de laud sang.

## **PALI 3 — Kapidolong oh katikitik kan**

Nan Pali 3, se peki kalelepak kan pid uwen ahmw kapidolong oh katikitik kan.

### **1. Kapidolong sang doadoahk (kan)**

- Menlau ndaiongiht uwen kapidolong kowe oh tohniwomw kin ale sang amwail doadoahk kan. Kapidolong kak kolang ahmw wasahn doadoahk de doadoahk me pein kowe kin wia.
- Ma mie ahmw wasahn doadoahk, kaselehda uwen kapidolong pwon. Kapidolong pwon wehwehki uwen mwoni mwohn daksis oh ehu soang en katikitik kan.
- Ma ke wia pein ahmw doadoahk, kaselehda uwen profit pwon ke ale. Uwen mwoni wet wehwehki uwen mwoni ke ale mwurin ke pwain anahn en doadoahk kan. Ke kak wadek duwen doadoahk en pein kowe, profit pwon, oh soang en isais kak me ke kak wadek ni **[www.irs.gov/individuals/Self-Employed](http://www.irs.gov/individuals/Self-Employed)**. Ke kak ndaiongiht duwen isais en ahmw doadoahk nan kalelepak 3 nan pali wet.
- Menlau kaselehda ma ahmw kapidolong tepida de nekla sounpwong wet. Met kak kahrehda ahmw ale kamwahu kan de soh.

---

### **2. Kapidolong sang wasa teikan**

Kaselehda soang en kapidolong ke pahn ale me sohte kolang ahmw doadoahk. Mie karasepe kan pah nan aplikeisin. Ekei karasaras iangahki: stipend kan, kapidolong en trust kan, kapidolong en iang sukuhl kan, oh kapidolong en sounpei kan. Mie dir en soang en kapidolong teikan. Menlau kaselehda uwen ahmw kak pid soang en kapidolong pwukat nan pali en “soang en kapidolong” pwe se kak wehwehki ma se anahne wadek nan OHP. Ma ke ale kapidolong en alimony, soang wet mwein sohte pahn wadek nan OHP. Sapeng kalelepak teikan pid alimony pahn seweseikiht pilada ma se anahne wadek nan OHP.

### **3. Katikitik kan**

Ndaiongiht katikitik kan oh soang en isais en doadoahk teikan me ke kin peki nan ahmw doaropwe en daksis en federal. Ni oaralp, ma ke peki katikitik ieu nan ahmw doaropwe en daksis en federal ke sohte kak peki katikitik ohte nan par ohte. Se sohte kak kihda peneu en daksis, ahpw ke kak kilang **[www.irs.gov](http://www.irs.gov)** de koasoaheng soundaksis men duwen ahmw anahne akan.

### **4. Uwen kapidolong nan ehu par**

Nan ekei pirokiram en wini kan, se kak wadek uwen ahmw kapidolong nan par pwon. Tehk mwahu me ke ndaiongiht uwen kapidolong en tohniwomw koaros nan par pwon. Tehk mwahu wadek uwen kapidolong me ke alehdahr nan par wet, mehnda ma e nekila.

Ni karasepe, ke ale kapidolong en unemployment nan Senuari, ahpw ke tepida doadoahk nan Pepweri. I ahmw tepida doadoahk, kapidolong en unemployment nekila. Ke pahn wadek uwen ahmw kapidolong en unemployment nan pali en “Kapidolong Teikan”

## **PALI 4 — Kalelepak kan pid tohniwomw teikan**

Nan **Pali 4**, sapeng kalelepak kan 1-6 nin duwen tohniwomw koaros, mehnda re sohte iang peki ale kamwahu kan, oh mehnda ma sapeng iei “soh.”

### **2. Emen me iang aplikeisin wet kin mihmi ni pil ehu wasa me kaidehn wasa me aramas keimen kin mihmi ie (*kowe*)?**

Ma mehmen sohte kin mihmi nan imwen aramas keimen, se anahne wehwehki ia wasa re kin mihmi ie. Kalelelepak teikan seweseikiht wehwehki dahme ke pengki irail pil iang aplikeisin. Re pil seweseikiht wehwehki ma se anahne arail ire kan pwehn pilada ma ke kak ale iang sawas en wini.

Mie karasaras pah pid soang en wasa kan emen kak mih ie ni arail sohte mih nan imwe:

- Wasahn ahpwalih aramas ni ansou reirei pwehki soumwahu de sounpar laud me ale mweimwei sang Department of Human Services. Soang en wasahn ahpwalih aramas iangahki:
  - » Adult Foster Care
  - » Residential Care Facilities
  - » Assisted Living Facilities, oh
  - » Group Care Homes.
- “Nursing home” (imwen ahpwalih aramas soumwahu) wehwehki ihmwe me aramas kin mihmi oh ale sawas en wini.
- Ma tohniwomw mih nan Oregon State Hospital, ke anahne pilada kohpwa karanih “Mih Nan Imwen Wini”.

### **3. Mie mehmen nan aplikeisin me liseian?**

Ma ke sehse iaht me ke pahn neitik, ke anahne kihda iaht me ke leme ke pahn neitik. Ma ke ese seri depe, menlau kaselehda. Ma ke sehse, sohte nting oh se pahn wiahki “1” ni aht wehwehki ma ke kak iang ale sawas en wini. Ma iaht me ke pahn neitik de seri depe wekila, menlau kahlikiht oh ndaionkiht.

### **4. Mie mehmen nan aplikeisin wet neitik de iohla nan sounpwong 3 samwalahro?**

Pirokiram en OHP kan kihda sawas en ngih oh pwoaren mese on irail me liseian. Re pil kak ale sawas pwukat sounpwong riau mwurin arail neitik. Se peki kalelelepak wet pwe se kak tehk mwahu me se kihonguhk kamwahu kan me keieu mwahu.

**Sapeng kalelepak kan 7-15 ma mie tohniwomw kan nan aplikeisin me peki iang ale kamwahu kan.**

### **11-12. Mie emen me masukun de pakolong? Mie emen me anahne sawas en wiewia mwahl kan iangahki aluseli, kainen, duhdu, de likouda?**

Aramas me masukun de pakolong oh anahne sawas en wia soang en wiewia kan powe kak ale kamwahu laud. Ahmw sapeng kan seweseikiht wehwehki ma ke kak ale kamwahu laud pwukat.

**14. Ndaiongiht menia pwihn en kihda sawas (CCO) me emen emen nan aplikeisin mwahuki.**

**Pilada pilahn en CCO nan ahmw wehi**

**Dahkot CCO?**
