Taropwen waiver noun Oregon me mwan

Ewe mwuun federal mei kan napengeni an epwe etiwa taropwen waiver non ekkoch ier non ew fansoun. Noun Oregon taropwen waiver a fen wor angangn ekkesiwin ngeni me atamano fansoun fan chommong seni chok non ewe 1994:

- Ewe taropwen waiver me nepoputan seni non 1994 a forata ewe OHP. Ei taropwen waiver mei kanapeno chon repwe tufichin nounou me pwan aninis repwe angei seni
- Ewe taropwen waiver mei ekkesiwin non 2012 mei forata ewe coordinated care organization (CCOs). Ekkewe CCO ir ew mwichen organization mei foruta me non ekkewe neni ir re moni health care.
- Ewe taropwen waiver mei ekkesiwin non 2017 mei foruta me pwan eochueno ewe model ren CCO.

Ewe taropwen waiver non 2022-2027 epwe kutta an epwe angang met ewe Oregon a fen forori ren angangen ekkesiwin ngeni mwokutun pekin health care fetaneochun ngeni:

- Forata ew system ren pekin health care an epwe nonnopok, fiti angangen eoreni me mecheresin pworous non foosun ekkoch pwan fonu
- Aninis won an epwe mecheres niiwin ren an epwe kawor pekin health care mei menemeneoch
- Fori angang epwe nonnopok me epwe fiti ngeni met ewe eoreni mei wor ren pekin health care, me pwan
- Fori pwe meinisin repwe tongeni angei ewe coverage mei menei repwe nomw won.

Ewe Oregon Health Plan (OHP) ina met an Oregon we Prokram ren Medicaid.

Ewe Medicaid ina an federal iwe prokram mei katou me non ew me ew state. Ewe mwuun federal mei aninis ne moni ei prokram.

Onnukun Federal:

- Affaten feffetanin angangen ei prokram.
- Affaten ifa ussun nonomwun aramas ren ar repwe tongeni tufichin nounou Medicaid.
- Affaten aninnis epwe kawor.

Me non Oregon, Medicaid, ewe mei fat pwe Oregon Health Plan (OHP), mei awora coverage ren pekin health ngeni arapakan emon me nein fomon aramasen Oregon seni ese nifinifin sokkun aramas.

Kich mei mochen sopwe rong sefan sonuk!

Usun ew prokram an mwuun, OHP mei nomw fan iten kich meinisin. OHA mei menei mefiom ren ach sipwe fori pew metewe kich mei onotanei won ewe taropwen waiver epwe ekkesiwin mei pwarano metekewe an community osupwang. Kich mei etiwa met mefiom won ifan usun ach sipwe fori pwe OHP mei namwot ngeni meinisin aramas non ach iei state. Kose mochen pwan chechemeni, mei pwan wor ekkoch mettoch mei keuk won metekewe ekkesiwin OHA mei tongeni wanong tingorun.
