Ewe federal government napengeni echok etiwa ika ese tichiki chon nounou ei pekin anisinin safei non fitu chok ier fan ew chok. An Oregon ei Medicaid waiver ika ese tichiki chon nounou a fen piin foor me akomw me pwan anapano fansoun seni ewe ier 1994:

- Ewe wesetan popun waiver non ewe 1994 a forata OHP. Ewe waiver a anapano ion epwe tongeni nounou me ekkoch aninis.
- Ewe waiver a for sefan non 2012 a forata ewe coordinated care organizations (CCOs). CCOs ir ekkewe organization won-sopw mei moni anisinin safei.
- Ewe waiver non ewe 2017 a for sefan iwe a pwan anapano met epwe mwirino ren ewe CCO.

- Aninis ren momon ren mwirino safei me tumunun semwen

Ewe Oregon Health Plan (OHP) ina ewe Prokramun Medicaid non Oregon.

Medicaid ew prokramun federal mei kawor me katou non ew me ew state. Ewe federal government mei anisi momon ewe prokram.

Onnukun federal:

- Affaten feffetanin angangen ei prokram.
- Affaten ifa ussun nonomwun aramas ren ar repwe tongeni angang nour Medicaid.
- Affaten aninnis epwe kawor.
