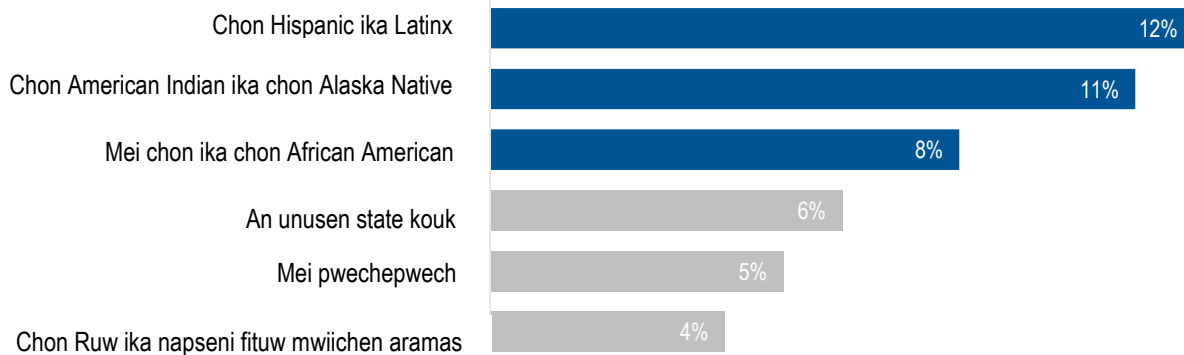

Ewe pandemic ren COVID-19 mei pwarano me angawano ekkei angangen pekin health ese nonopok. Iwe nge, awatenon me afatenon angangen an emon epwe tufichin nomw non mei fis meren ewe CARES Act mei fori an epwe kukununo "mwokutun" chon nounou Medicaid (ren an aramas repwe angei ika tou seni coverage me non ukukun ruw ier). Kich mei angang ngeni ach sipwe fori pwe epwe fetaneoch angangen ekkei onnukun coverage.

Mei chommong pwopun an aramas rese nounou insurance. Chommong ngenir ir mei tufichin nounou ewe OHP nge rese sinei, nge ekkoch chon nomw Oregon rese nounou insurance ir mei churi sokkun mettoch mei eppetir ar repwe tongeni nounou coverage pwokiten nonomwun ar tonong ngeni ei fonu ika pwan ekkoch mettoch epwe tongeni eppetir ar repwe pachenong me

Ekkei tetenin met epwe fis mei tetenitiw fan ina met angang won pwe epwe ponuweta ach kokot me anean. Ei anapanapen angang epwe fori an epwe tongeni pwoueta ren an epwe ochufengeni met masowen non ewe taropwen waiver me met esapw masowen non ewe taropwen waiver an epwe anganga.

Step 1. Sipwe nengeni fichi pwe ekkewe aramas rekeran pachenong non OHP fan iten ei COVID-19 iwe repwe nom non meni mei awenewen ngenir (OHP ika Marketplace) nge esapw pwan keuno.

Kich mei kuna napanon aninisin nounoun ei OHP non ei fansoun ren ewe COVID-19 fan iten ekkewe annuk mei for awenewen ngeni chok ei popun osukosuk. Ekkei annuk mei fori an aramas repwe tufich pachenong me nounou ei insurance, a pwan mutata an repwe pwisin-pwarata ar moni tonong, me ekewin ren ar repwe tongeni nounou sefan. Oregon e mochen sopweno met a fen anganga me fori won ei popunapan an epwe sopwosopwono ne anisi ekewe re katonong non OHP fansoun ewe pandemic nge mi siwin keukun an ar moni tonong. Ren ekoch case, wewen pwe ekewe aramas ir mi nom won OHP re menei aninis an repwe mecheres ne siwin ngeni ew health plan mi kaor won ewe Marketplace.

Step 2. Tumunu pwe aramas ra fen pachenong me tufichin nounou OHP repwe chok sopsopono ne nom won ei insurance.

Fansoun ekkei watten ekewin a fis me non ewe ONEligibility System, mei chok pwan wor nenien ekewin ren met epwe mwirino nupwen sipwe ekieki ekkei sokofesen me met mei epeti aramas fansoun ar repwe pachenong me nounou ei insurance. An Oregon we Sopwosopwonon Aninis fan iten chon Tufichin Pachenong non OHP/CCO mei ren ekkewe semirit ew system mei fokkun pochokun mei nuuno seni met sokkun aninis epwe kawor ngeni ekkewe serafo ir mei nounou

insurance seni ekkewe kompeni. An Oregon we Sopwosopwonon Aninis fan iten chon Tufichin Pachenong non OHP/CCO mei ren ekkewe semirit ew system mei fokkun pochokun mei nuuno seni met sokkun aninis epwe kawor ngeni ekkewe serafo ir mei nounou insurance seni ekkewe kompeni. Ei pekin angei fite ukukkun aramas me nonomur mei pwan ngeni kich ach sipwe sinei ion ese mo pachenong nge sipwe esinesin ngeni pwe ir mei tongeni nounou ei insurance. Ach sipwe anonga ach ekiek won "chon tufichin nounou nge esapw chon pachenong non" ren pwan sopwosopwun angangen osukun epwe tongeni anisi ngeni kich pwonuetan met kich mei angang fan itan fan iten an ese nonnopok chon repwe tongeni nounou ren sakofesenin mwiichen aramas.

Step 3. Anonopokuw chon tufichin repwe nounou pwe epwe tongeni sopwosopwono.

Pwokiten mei sakopat me wor epinasen angangen ewe pekin health insurance marker, ekkoch aramas a ina met a kan soun fis ngenir ar repwe sopwosopwono ne nomw (ika "mwokut fetan") ne tonong me tou seni ar tufichin repwe nounou ika nomw non. Ewe Survey ren Oregon Health Insurance mei pwari pwe non ewe 2019, 35 pesen aramas ese wor ar coverage rese insure pwokiten ar "tou seni ewe coverage an OHP." Ekkei sokkun ekkesiwin mei eweiresi me mei pwan tongeni ekkesiwin manaw ngeni aramas pwokiten an turusenir ewe aninis ngenir me angawano nefiner me ekkewe chon awora aninis ngenir ir mei nukunuk non ir. Oregon mei angang ngeni an epwe anapano coverage ngeni semirit me famini, me pwan achouwano coverage fan iten ekkewe chon Oregon mei kukun ar moni tonong iei rese tufichin repwe nounou OHP, ika pwe epwe tufich.

Anapanapen angangen ewe taropwen waiver

Fori pwe epwe mecheres an emon epwe nounou coverage me epwe nomwonong chok non ewe OHP epwe tongeni pwonueta ren ekkoch sokkun nikinikin angangan epwe tongeni fis. Non ekkoch case, ei angang a fen fis ren ewe angangen Anapanap ren Aninis Fengenin iwe mei menei an epwe wor opochokunen angangan. Ekkei mei nomw fan ikkena ekkoch sokkun anapanapen angangan me onnuk.

Awora ngeni ekkewe semirit ar repwe sopwosopwono ne tufichin nomw non ukukun 5 ier.

Oregon mei awora tingorun an semiriti repwe sopwosopwono ne tufichin nomw non ukukun 5 ier, ewe epwe tongeni fori pwe esapw chiwen wor ar repwe tufichin nenengeni ar repwe nounou Medicaid me CHIP iwe epwe tongeni angangawano nonomwochun ar tumwun me mamarita. Oregon mei fori iei ew nikinik an federal ren 12 maram an semirit repwe tufichin sopwosopwono ne nomw non, ekkewe ier 0-18, fiti ar repwe fori pwe nupwen ekkewe semirit ra 19 iwe resapw chiwen nomw non ika tou seni ewe state ina met an federal onnuk.

Sopwosopwonon tufichin an emon semirit epwe nomw non epwe ekisano ar repwe "mwokutfetan" ren ekkewe semirit ir repwe mefi osupwangen ar nomw won me rese nomw won Medicaid. Ei epwe tongeni eochueno tufichin an emon epwe nomw non me sopwosopwono angangen tumwun ngeni ren an epwe eochueno touran ren pekin health me met mei fis me murinon. Pwokiten mei chommong semirit ir mei tufichin repwe nounou ewe coverage, katanon ewe angangen omwokutu epwe ekisano met niwin ren pekin administrative me weiresin ngeni famini me pwan ewe state ren angangen taropwen application. Iwe pekinon, awatenon ewe ukukun semirit ion repwe

sopwosopwono ne nounou epwe muttir ekisano niiwin ren emon me emon member mei nomw non ewe coverage.

Met wewen ei ngeni ekkewe member non OHP?

Ren ekkewe semirit mei nomw non OHP, wewen ei pwe ewe coverage ren health insurance me ar tour ngeni aninis meren ekkewe chon anisir ra eorenir epwe tongeni ew chok nikinikin non ew nakatamen fansoun, akkaewin nupwen ar nomw non pre-school me ar ra nomw non ierin watte. Ren sam me inn me ekkewe chon tumwun semirit non OHP, wewen ei pwe epwe kisino chon tufichin repwe nounousefan, me kukununo ar repwe eureki ika pwe mei wor ekkesiwin non pekin ar angang ren an epwe angawano tumwunun ewe semirit.

Mwutata an chon ammasow nour taropwe repwe pusin anetata ukukun ar moni tonong.

Mwuut ngeni ekkewe chon amasow nour taropwe ar repwe pusin anatata ar moni tonong ina ew onnuk mei pwonueta ewe mei fisita ren ei COVID-19 pandemic. Oregon mei mochen epwe anomwano chok ekkei onnuk pwe epwe eochueno angangen ewe taropwen application me angangen nenengeni ika epwe tufichin nounou. Ei onnuk a fen piin emwitrano fetanin chon amasou nour taropwe ngeni ar repwe nounou me pwan tour ngeni anisir ren an a fori pwe ekkewe chon nomw non ewe coverage repwe nengeni unusen ar moni tonong.

Met wewen ei ngeni ekkewe member non OHP?

Ren ekkewe aramas ir mei tufichin repwe nomw non OHP repwe tongeni angang ngeni fengen me ewe Chon Aninis ren Application ika fen pwan pacheong non ewe angangen pusin anetata ar moni tonong ren OHP ika ifan koukun ar coverage, iwe repwe tongeni pwan fansoun an epwe kochufengen taropwe mei auchea ngeni an epwe opungano ewe ukukun moni tonong, pachenong pwan ekkoch sokkun nikinikin angangan (awewe, ika pwe ir mei keran chok pachenong ar repwe nounou ewe SNAP). Nupwen epwe tufich, Oregon epwe kuta anepwe nounou met data a fen wor ren an epwe ekisano an ekkewe famini osukosuk.

Repwe sotuni ne nounou ekkewe onnuk ewe epwe anisi ngeni ekkewe famini ar repwe chok sopwonono ne nounou fengen ewe coverage ika mwo a ekkesiwin ewe moni tonong ngenir.

Oregon mei fori pwe epwe angang fengen me ewe mwuun federal ne kuta ekkoch anen aninis epwe tongeni fori an ekkewe famini mei nomw non ekkewe CCO, inamwo ika mei wor sakofesenin tufichin ar repwe nounou anongonong won ar moni nomw non ren nefinen semirit me ekkewe mei mwuk ir mei nomw non ewe koukun moni tonong mei wor ren ewe OHP me pwan ekkoch kinikinin me non ei Marketplace. Mei tongeni pwe ei onnuk epwe fori an epwe pwan wor sopwosopwun taropwen waiver ika ekkoch anen ar repwe tongeni pwonueta pwe epwe forano ekkewe sokkun mettoch mei wor ngeni aramas non ewe Marketplace, ren an epwe nomw non ewe CCO.

Angangen kaeo ngeni mei pwarano pwe pochokunen semirit me ar mamarita mei anongonong won pochokunen iner me semer, iwe mei pwan auchea an ekkewe sam me inn repwe pwan sopwosopwono ne nomw non ewe coverage ren tufichin fansoun. Sopwosopwonon, nupwen ekkewe sam me inn ra nomw non me ra pwan eoreni ifan usun nikinikin ar repwe mwokut fetan

non ei system, mei pwan anapano mecheresin ngeni ekewe semirit ren ar repwe tour ngeni sokkun angangen aninis ngenir.

Met wewen ei ngeni ekkewe member non OHP?

Ren ekkewe member irchon ewfamini, semirit mei tongeni repwe nomw tori wattenon koukun moni tonong, iwe pwan ekkewe mei mwuk ir member. Wewen ei pwe ekkewe member rese pwan menei ar repwe kuta met sakofesenin aninisin insurance ngenir ika kuta sokkun pwan network ren ekkoch pwanchon ar we famini.

Awatenoi coverage ngeni ekkewechon Oregon mei kukun ar moni tonong iei rese tufichin nounou

Oregon a fen piin sopweno ne fori an epwe awatenoi touren aninis ren OHP ngeni ekkewe aramas mei kukun ar moni tonong nge rese tufichin repwe nounou pwokiten nonomwun ar tonong ngeni ei fonu. Ei mei fis ren ekkewe semirit kukun seni ier 19 ren ewe prokramen Pachenong Meinsin Semirit non 2017. Oregon mei sopweno ne awora aninisin moni seni state ngeni ewe angangen coverage ren arapakan ukukun 6,500 semirit (seni ar uputiw tori ier 19) won ika kukun seni 300% koukun ren an federal (FPL) iokewe ir rese tufichin nounou ewe Medicaid pwokiten nonomwun ar tonong ngeni ei fonu, me pwan coverage ren osukosuk atapwanapwan ngein 42,834 mei mwukchon eto seni pwan ew fonu won ika kukun seni 138% FPL meren ewe Citizen Alien Waived Emergent Medical Program (CAWEM).

Ewe angangen aninis ese nonopok ren tumwun seni COVID-19, angangen tes, safei ren samwaau, me pwan opposun eppet non ei fansoun pandemic mei pwarano mutirion me auchean an epwe wor angangen aninis ren pekin health ngenichon Oregon meinsin. An epwe tongeni pwonueta met Oregon mei angang fan itan an epwe awesano an ese nonopok angangen pekin health tori non 2030 me pwan awesano metekewe mei eppetitufichin an emon epwe nounou, nomw non ewe coverage me pachenong non, Oregon epwe awatenoi an emon epwe tongeni tufichin nounou ren ewe coverage ngeni meinsinchon etto nonomw won ei fonu non ei state. Ruw bill mei mwokut me non ewe Mwichen Legislative epwe tongeni awora an Citizen/Alien Waived Emergency Medical (CAWEM) prokramen wraparound (itenapan "Pachenong Meinsin Aramas") ngeni iokewe mei mwuk ese wor taropwe fan iter.

Fiti ngeni met omwokut seni ewe anepwung fan iten ewe bill Apachanong Meinsin Aramas, me unuseochun an Kepina pachenog non ewe angang, Oregon mei fori ar repwe kochufengen me ewe mwuun federal ne kutta sokkun anen aninisin moni epwe anisi ekkewe anen aninisin moni an state me federal fan iten ekkei mwiichen aramas pwe epwe tufichin pwonueta ew prokram mei wor namwotan me ochupanong meinsin non. Ekkewe nusun non ei state rese insure mei pachenong fitemon aramas ir rese wor nour taropwen ar repwe nonomw, napengeni ekkewe ir mei kan kuna sokkun weires ren nipwakingaw non kapas, sokkun ar eoreni ika ir mei mefi nuokusun ar repwe tour ngeni aninisin coverage me tumwun.

Met wewen ei ngeni ekkewe member non OHP?

Oregona epwe sopweno ne angang an epwe anapano me awateno an coverage non ukukun an tongeni pwe epwe fori pwe ekkewe aramas mei kukun ar moni tonong repwe tour ngeni anen aninisin coverage ren health care, inamwo ika ifan usun nonomwun ar tonong ngeni ei fonu.

Kuta ekkoch mettoch mine epwe anisi mecheresin pwe epwe tufich ngeni an federal we aninisin moni ren Affordable Care Act pwe epwe tongeni pachenong ekkewe aramas mei tufichin nounou.

An epwe fori pwe aramas ion mei tufichin nomw non ewe Medicaid ir mei nomw non, ekkewe anen aninis ren tou ngeni aramas me angang ngeni aramas mei menei an epwe chomongono ukukun aninisin moni. Oregon mei angang ngeni an epwe awateno sokkun moni mei wor seni federal an epwe anisi nape non chon repwe tongeni nounou ren ekkewe ir mei tufichin repwe nounou.

Met wewen ei ngeni ekkewe member non OHP?

Ren ekkewe aramas ion mei tufichin repwe nounou nge rese mwo nomw non, ouwa tongeni kuna pwan sopwosopwun aninis ren tou osukun me anagng ngeni aramas pwe epwe tongeni anisi ngeni kemi ami oupwe pachenong non OHP, non pusin foosun fonuemi ika meren ekkoch ach kewe partner kich mei angang fengen me ekkewe organization an community.

- Kuta pwan ekkoch anen ar repwe chiechi ngeni ewe Departmen ren Consumer me Business Affairs (DCBS) pwe repwe wewefich ngeni ekkewe sokkun anen aninis ren an epwe eochueno an aramas repwe tufichin nounou ekkewe mei kan wor ar mwokut fetan me non OHP me ewe Marketplace
- Ren ekkewe semirit, ekkewe ekkesiwin mei anonga won anepwe eochueno touren aninisin tumwunun pekin behavioral health non unusen ei state ren an epwe awateno ika kanapeno ewe coverage, fori pwe touren aninis ren ewe koukun tumwun, me pwan eppeti an epwe chomong-system epwe pachenong ren ar repwe uwau metewe mei angawano me eochueno ewe touren aninisin tumwun.
