Ei angangen commitment epwe tongeni ochufengeni met sopwosopwun ewe angang an epwe fori pwe ewe CCO epwe fori ururun wisan ngeni noun member me metekewe osupwang an ewe community pwe epwe wor namwotan an epwe anonga an mwokutukut won nonnopokun aninisin pekin health me awora sefani ewe aninis ngeni ururun met moni epwe kawor ngeni ekkewe community.

Ew kiien an epwe eochuno ewe angang, ewe aninis ren met sokkun epwe kamotiw meren CCO – mei fat pwe ina ena budget ren unusan.

Fan nurun ena budget ren unusan, CCO ir ra wisen mesemes won ar repwe angang fengen ren unusen angangen aninisin, pekin inis, pekin behavioral, me pekin kapas. Pwan ir mei pwan tufichin repwe tongeni awora aninisin moni ren pwan ekkoch sokkun aninis mei eochuono nonomwun pekin health ren ewe aramas me ewe community, awewe ren pekin imw ika aninisin mongo, non unusen an Oregon prokramen sokkun aninisin pekin health (HRS). An CCO we budget ren unusan mei pwan pachenong ukukun niiwin epwe tongeni kamotiw ren ewe koukun, seni 2% ngeni 4.25% me non ewe budget ren unusan mei kamotiw ngeni ekkewe CCO. Ekkei aninisin moni mei awora eochunon ren ewe koukun angangen aninis me kawor; awewe ren, nefinen ewe ier 2011 me 2019, ewe fansoun osupwang mei napeno won ukukun ruw me angangen ewe putain emergency mei turutiw ngeni 14%. Unusen an Oregon budget, HRS, ekkewe prokram mei namwot ikena met kiien an epwe sopwosopwono angangen tumwunuw wattenon niiwin nge eochuono angangen pekin health. Iwe nge, mei pwan chok wor ekkoch mettoch mei eweiresi an epwe tufich. Pekin health care ina ew me nein ekkewe masowen non an Oregon iwe state budget mei kon auchea niiwinin. Iwe non pwan ei fansoun, chon nonomw Oregon ir mei chuuri sokkun osukosuk non unusen ei state, sokkun atapwanapwan mei fis ren ei mettoch climate change, me pwan napenon an ese nonopok aninis ren fan iten sakofesenin mwichen aramas.

Non an ekkwe CCO repwe fetaneoch me napeno angangen aninisin moni ngenir ar repwe moni ngeni sokkun aninisin pekin safei, napengeni ekkewe CCO ir mei chok moni kukunseni ukukun 0.5% me non ar budget ren unusan ren sokkun aninis mei ururoch ngeni. Ei fan iten mei wor ewe koukun ifan ukukun moni repwe nouni mei afatetiwi me pwan wor angangen nenengeni won. Mei pwan wor ekkoch pwangenon mei pwano ren ewe pekin behavioral health, akkaewin ren ekkewe semirit ir mei kon sakopat sokkun ar osupwangen aninis me ekkewe aramas ese nonnopok aninisin pekin health ngenir. Awewe chok, usun ren met masowen ewe taropwen waiver 1115, Oregon mei tour ngeni mwumwutan an epwe fori an angang epwe eochu ngeni ekkewe CCO anongonong won watenon aninisin pekin moni mei wor ren ewe pekin health nge epwe pwan tori ewe koukun ren ewe pekin aninis me ren ewe niiwin. Ei prokram, iei a iteni Performance-Based Reward (PBR), epwe pwoputa pochokunen koukun angangan ren ekkewe CCO non 2022. Iwe mwo Oregon a pwoputani ne kuna pwe mei watteno aninis epwe tongeni kawor meren ekkewe CCO non 2020 ren met kunaen ewe PBR, mei chommong ekkesiwin epwe wor pwe epwe tongeni angasano metekewe mei eweiresi me eppetifefeitan nonomwun Oregon.

An Oregon we Sopwosopwonon Aninis fan iten chon Tufichin Pachenong non OHP/CCO mei ren ekkewe semirit ew system mei fokkun pochokun mei nuuno seni met sokkun aninis epwe kawor ngeni ekkewe serafo ir mei nounou insurance seni ekkewe kompeni. An epwe pwonueta fetaneochun angangen ewe system ren pekin health mei tongeni epwe anisi ngeni sokkun nongonong ren an epwe awena ekkewe ngawen angangen nifinifin ngeni aramas pwokiten ir seni meni pmwichen aramas, ese nonnopok pungun nemenem, me ese nonnopok angangen pekin health. Iwe pwn sopwosopwun, ewe budget epwe pwan masoni met sokkun aninis epwe tongeni anisi ngeni an ekkewe member osupwang, epwe mecheres ngeni ar repwe weweti, me pwan mecheres ngeni ar repwe tongeni kuna ekkewe community me ewe state.

Met ekkesiwin mei wor ngeni ekkewe contract mei fori pwe ekkewe CCO repwe ochufengeni me forata kokkoutun omwokut non ekkewe community an epwe eochueno angangen pekin health fiti fengen me ekkewe pioing me public health pwan usun chok ren ekkewe organization non ekkewe community me ekkewe kinikinin tribe, anapano an pungun angang an CCO pwe epwe anisi met osupwangen non ekkewe community. Non ewe minafon taropwen waiver, Oregon mei mochen epwe fori met an mwokutukut won met angang a fen fisieoch ngenir ren an epwe pwan pachenong met repwe tongeni kutta ngeni an epwe anisi me eochueno nonnopokun angangen pekin health.

An epwe sopwosopwono fori pwe member non Medicaid mei toureoch ngenir me nonnopok ngenir pekin aninis, nge akkoumwa non kokkot ekkewe mwichen aramas ir mei kan kon kuna me mefi an ese nonnopok ngenir aninis, Oregon mei wanong non an omwokut an epwene fori ruw kinikinin anen aninis ren ewe prokram non an epwene ruw sokkun nikinikin angangan. Ekkewe ruw sokkun nikinikin angangan epwe for fan iten met ngawenon me pwan fefeitan met sokkun angangen nonnopokun angangen pekin health.

Ewin masowen ewe prokramen aninis epwe fiti ngeni met koukun angangen aninisin pekin health, met kunaier, me pwan met repwe anganga ren met ir mei fori non unusen ei fonu ("met mei efefetiwa kutten fetanin ewe

Fansoun CCO mei angang won mecheresin budget an epwe anapano met epwe kawor fan iten tumunun-safei ngeni aramas fan nurun ewe HRS, met epwe kamou epwe chok mokukun usun ewe medical care. Napenon, usun mei pwa pwe mei watte sokofesen ren semwen mei katonong tungor esapw fan iten chok katonong mwirino community nge epwe pwan wor chiechi fengen me ekkewe community health, nge mei wesen apochokun community epwe awora angang fengen nefinen ewe CCO me ewe community. Ei angang mei menei esapw chok an epwe forata pochokunen ew anapanapen angangen opwungano kokkot me fetanon me non community – mei menei an epwe forata ekkoch sokkun ekiiek epwe feito meren *meren* community me angang fengen ne forata ew minafon anapanap ren angang epwe *ngeni* community.
