



## Fofforun ew sokkun angang ren kaworen mwoni ren health me kaworen mwoni ren anonnopokun aninnisin angangen health

En Oregon Health Plan (OHP) ese kame ngeni chon fitir, ekkkan kafomonun state me federal ir re wiisen meoni. Iteiten ier, mei keki niwinin aninnisin tumwunun nonnomwun aramas. Fite ukuukun an keki iteiten ier, ina ena re eita ngeni "keki niwinin".

Oregon a ekukkunatiw fansoun en epwe keki niwinin ren ar meon ngeni ekkkan coordinated care organization (CCO) ei minne-ka itan "pwachetin meinisin", nap seni ar repwe meoni ew me ew sokkun aninnisin re atoura ngeni nour aramas. Ei angang e emecheresi an ekkkan CCO repwe foreochu feffetanin ar pwachet. Ren awewe, ir mei tongeni nounou nour mwoni ren *eppetin* semwen, mwen ar nouni ne *safeni* aramas ren ar semwen.

Ren feffetaneochun ei angang, Oregon a mwoneta ne sopweno ar angang: meoni ekkkan CCO ren ei "kefinin-meon ren pwachetin meinisin". Wewen pwe ekkkan CCO repwe fori angangen aninnisin aramas ren tumwunun inisir, netipar, me tumwunun ngiir, *me* anisi nour aramas ren met mei auchea ngeni tumwunun nonomwur, awewe ren imwar me ar mwongo.

**Pwachetin meinisin:** Ew pisekin angang an epwe mecheres ngeni ekkkan coordinated care organization ar repwe fini ian epwe no ia nour mwoni ren aninnisin epochokkunen nonnomwun aramas me otufichi ar angang (mochen) non ar angang fengen me en state me chon angang ngeni public.

**Kefinin-meon ren pwachetin meinisin:** Ekkei pwachetin meinisin mei menei an ekkkan chon CCO repwe atoura ngeni ekkkan chon fiti OHP aninnisin, awewe ren imwar me ar mwongo.

## Fofforun angang ren an epwe mecheres kefinin-meon ren pwachetin meinisin, an ekkkan CCO repwe fori angangen anonnopokun aninnisin health ngeni meinisin

Fan ei, mei wor ekkoch pekin angang en Oregon Health Authority mei mochen epwe tingor ngeni ewe federal an epwe mwut ngenir pwe repwe fori:

1. **Menei an ekkkan CCO repwe kamenong non ekkkan angangen tumwunun an aramas health pwe e murinno nonnomwun aramas ren.** Napengeni, Oregon e mochen an ekkkan CCO repwe meoni 3% ar kefinin-meon ren pwachetin meinisin ren anonnopokun aninnisin health ngeni meinisin, och epwe no ngeni chon angang non nenien aramas minne-ka itar ei, community investment collaboratives (CIC). 2. **Oregon epwe awora ngeni ekkkan CCO ew pwachetin meinisin epwe mecheres me ffat feffetanin non ekkei fansoun mwach.** An ekkkan CCO ffat ren feffetanin ar pwachet me ifa ukuukun nesor me peonon, mei emecheresi ar repwe awora mwonien anonnopokun aninnisin health ngeni aramas, *eppetin* samwau me aninnisin nonomwun aramas non neniar. 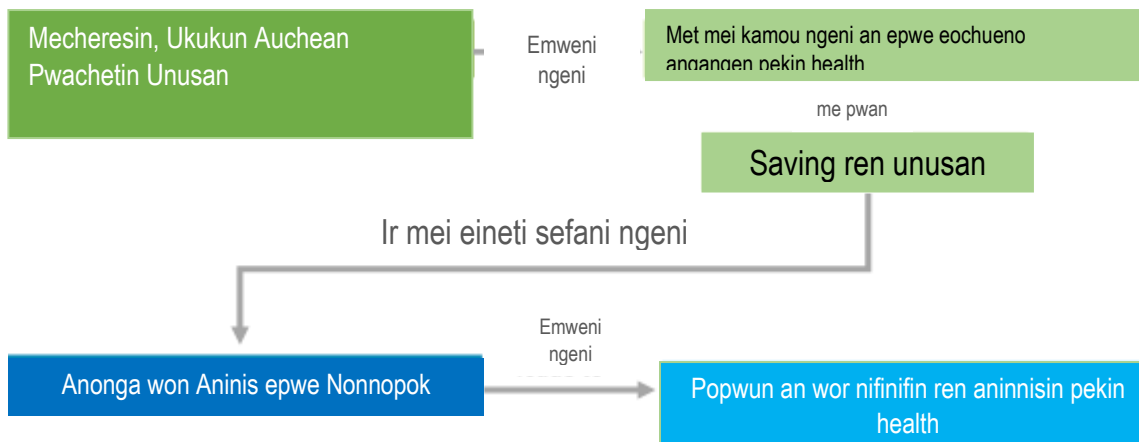
epochokkuna an aramas health fengen me ekukkunatiw niwinin tumwunun health nesor me peonon.
