1. Fori sefan ewe Quality Incentive Program ngeni ruu kinikin

Oregon e mochen tumwuneochu pwe meinisin chon tonong non en Oregon Health Plan epwe kawor me atour ngenir aninnisin angangen tumwuneochun ar health. Angangen pwuuta

Angangen pwuutiw

Ei pwan ew pekin angangen prokrammin kaworen mwoni nge ren met angangen aninnisin health mei kawor meren ekkan Medicaid organization non unusen ei fonu. Angangen aninnisin health ussun ekkei epwe kawor meren chon angang ngeni federal ren pekin Medicaid, ewe Center ren Medicare me Aninnisin Medicaid. Ekkei sokkun angang nge ren angangen tumwunun samwau, aweve ren chekiin maan suke me tumwunun nonomwun semirit.

2. Inetin epochokkunen kefin ngeni aramas non ar nenien nonnom ika community

OHA mei nuku pwe ekkan aramas non ar community re kuna weiresin an epwe kawor ngenir aninnisin ar health, mei auchea an epwe wor ar pochokkun ar repwe kefin met epwe siiwin me ifa ussun an epwe siiwin. Ren aninnisin an epwe fisino, OHA mei fori kokkotun ar repwe angang fengen me en Legislature ar repwe siwini en Health Plan Quality Metrics Committee, ika kokkotun, ngeni en Health Equity Quality Metrics Committee (HEQMC), ika anonnopokun. Chon non ewe HEQMC repwe angang fan iten ekkan aramas ir mei kuna weiresin kaworen aninnisin health ngenir: chon fiti OHP, aramas non ekkan community re etto seni sokkopaaten fonu, aramas re apwangapwangeno ren an ese nonnopok aninnisin health ngenir, me ekkan soutipachem me chon angangen anonnopokun aninnisin health.
