Ilo 2021, ñan an woñmaanlok an oktak burokraam eo an Medicaid an Oregon, einwōt ad bar jelā ej Oregon Health Plan (OHP) Oregon Health Authority (OHA) ej kōmmane kōnaan, kōtōbar, laajrakin kōmadmōd ko im juon ablikajon.

Kōmelim in jab aikuj ko moktalok an Oregon

Kien eo an federal ekkā wōt an kōtōbrak kōmelim in jab aikuj ko ñan jet yiō ilo juon ien. Kōmelim in jab aikuj eo an Medicaid eo an Oregon emōj an kōkkāāl im lablok elōñ alen jen 1994:

- Kōmelim in jab aikuj eo kein kajuon ilo 1994 ear kajutak OHP. Kōmelim in jab aikuj in ear kōlablok woñ ro remaron tōbrak im jibañ ko.
- Kōkkāāl in kōmelim in jab aikuj eo an 2012 ear kajutak doulul in kōlaajrak kejbarok ko (CCO). CCO ko rej doulul ko ilo jukjukinbed rej kolla wonnen taktō.
- Kōkkāāl in kōmelim in jab aikuj eo an 2017 ear loor im kōkmanmanlok jekjekin madmōd eo an CCO.

Ta in Medicaid?

Oregon Health Plan (OHP) ej Burokraam in Medicaid an Oregon.

Medicaid ej juon burokraam an federal im kajojo state ej lale. Kien eo an federal ej jibañ kollaiki wonnen burokraam eo.

Kakien eo an Federal:

- Ej karōke joñan ko kin wāween an burokraam ko jermal.
- Ej karōke joñan ko ñan maron tōbrak ñan Medicaid.
- Ej karōke jibañ ko rej mennin aikuj.
