Cov me nyuam muaj hnub nyug 5 xyoos thiab laus dua ntawv tuaj yeem txhaj tau tshuaj tiv thaiv COVID-19.

Suav txij lub 5 Hlis 2021, cov hluas muaj hnub nyug 12-18 tuaj yeem txhaj tau cov tshuaj Pfizer tiv thaiv COVID-19. Pib hnub tim 3 lub Kaum ib hlis xyoo 2021, cov me nyuam yuas muaj hnub nyug 5 txog 11 xyoos yuav tau txhaj cov tshuaj Pfizer tiv thaiv COVID-19 rau.

- Me nyuam mos muaj 6 hli thiab loj dua ntawv tuaj yeem txhaj tau cov tshuaj tiv thaiv khaub thuas (flu). Niam txiv thiab tus saib xyuas me nyuam yuav tau coj me nyuam tus muaj 6 hli txog 2 xyoos mus txhaj tshuaj tiv thaiv khaub thuas (flu) rau ntawm chaw kho mob me nyuam yaus.
- Cov muaj hnub nyug 15 xyoos nce lawm tsis tas yuav tau kev tso cai ntawm niam txiv.

Ziag no cov khw muaj tshuaj los tuaj yeem txhaj tau tshuaj tiv thaiv COVID-19 thiab khaub thuas (flu).

Cov niam txiv thiab cov saib xyuas me nyuam yuav tau coj me nyuam mus rau OHP los sis CAEM cov khw muaj tshuaj thiab txhaj tshuaj tiv thaiv rau me nyuam.
