## **Cov menyuam yaus hnuv nyooog 5 xyoos thiab laus dua tuaj yeem tau tshuaj tiv thaiv COVID-19 thiab koob tshuaj ntxiv.**

## **Oregon Health Plan (OHP) npog COVID-19 thiab tshuaj tiv thaiv kab mob khaub thuas rau cov tswv cuab ntawm OHP thiab CWM.**

- OHP cov neeg laus thiab cov menyuam yaus tuaj yeem tau txhaj tshuaj tib lub sijhawm, lossis thaum mus ntsib kws kho mob sib txawv.
- CWM cov tswv cuab yuav tsum tau txhaj koob tshuaj thib ob ntawm tib tus kws kho mob mus ntsib. Cov tshuaj tiv thaiv kab mob khaub thuas tsuas yog them thaum tau txais tib yam li cov tshuaj tiv thaiv COVID-19.

COVID-19 thiab tshuaj tiv thaiv kab mob khaub thuas muaj nyob hauv khw muag tshuaj, chaw kho mob, chaw kho mob hauv zej zog, thiab tsev kho mob.
