Oregon Health Plan (OHP) npog COVID-19 kuaj hauv tsev rau OHP thiab CWM cov tswv cuab.

- OHP thiab CWM cov neeg tus muaj tsos mob COVID-19 los sis tau mus nyob nrog tus mob COVID-19 lawm tuaj yeem tau ntsuam xyuas COVID-19 rau ntawm tsev.
- Ntsuam xyuas COVID-19 ntawm tsev nws hloov tsis kev ntsuam xyuas COVID-19 ntawm chaw kho mob thiab chaw sim.

## **OHP thiab CWM cov neeg tuaj yeem tau txais kev ntsuam xyuas COVID-19 ntawm tsev ib hlis 8 zaug uas t sis muaj kev tso cai ntawm kws kho mob.**

Txhawm rau kom tau txais kev ntsuam xyuas ntau dua yim zaug ntawm ib lub hlis, OHP thiab CWM cov neeg yuav tsum tau thov kev tso cai ntawm kws kho mob.

- Thov tiv toj rau koj tus kws muab kev pab kho mob (PCP) yog tias koj xav tau kev ntsuam xyuas ntawm tsev ntau tshaj yim zaug ntawm ib lub hlis.

## **Txhua hom COVID-19 yeej tau txais kev pab ntsuam xyuas ntawm tsev.**

OHP yuav pab ntsuam xyuas txhua hom COVID-19 ntawm tsev uas tau kev tso cai los ntawm Meskas Chaw Pov Tswj Khoom Noj thiab Tshuaj (FDA), suav nrog kev ntsuam xyuas COVID-19 ntawm tsev uas thov kom muaj kev txuas nrog internet los sis xov tooj txawj ntse kom tau nyeem cov ntawv ntsuam xyuas.

## **Txais kev ntsuam xyuas COVID-19 ntawm tsev rau ntawm chaw muag tshuaj los sis khw muag khoom.**

Cov tswv cuab yuav tsum nqa cov ntawv ntsuam xyuas COVID-19 rau chaw muag tshuaj saib thiab qhia khw tshuaj paub tias lawv yog OHP los sis CWM cov neeg. Cov tswv cuab yuav tsis tau them nqi ntsuam xyuas COVID-19 ntawm tsev.

- Vim cov kev pab muaj kev txwv, tsis yog tias txhua lub khw muag tshuaj los sis khw muab khoom yuav tuaj yeem ntsuam xyuas COVID-19 tau rau ntawm tsev. Cov tswv cuab puas xav hu xov tooj rau khw muag tshuaj los sis khw muag khoom puas tseem tshuav kev ntsuam xyuas COVID-19 ntawm tsev nyob ntawm cov khw lawm.
- OHP yuav pov hwm kev ntsuam xyuas ntawm tsev nyob rau ntawm khw muag tshuaj, tab sis tsis yog ntsuam xyuas hauv online.
