Non February 29, 2020, ewe Putain Human Services a uwau ew emwenin, me annukun chuto non ekkewe imwen tumun mei semwen, pachenong ekkewe imwen chinap.

Non March 2, 2020, ewe Pekin State of Oregon Emergency Coordination Center a poputa fori an angang.

Non March 8, 2020, Uwa apungano pwe ei osukosuk atapwanapwan a mak non annuk nampa ORS 401. 165 *et seq.* pokiten ei semwen mei afeiengawa aramas ei coronavirus (COVID-19).

Non March 12, 2020, Uwa esipano an aramas repwe chufengen ren ukkukun 250 ika nap seni, me esinesin epwe kesipino K-12 non Oregon seni March 16, 2020, tori March 31, 2020.

Non March 13, 2020, ewe President non United States a apungano pwe watenon ei COVID-19 ew osukosuk atapwanapwan non unusen Merika.

Non March 17, 2020, Uwa esipano an aramas repwe chufengen 25 ika nap seni, ese pwan wor epwe mongo me unumi non-neni ren ekkewe nenien mongo me un, kesipinon sukun mei pwan sopouloso tori Aril 28, 2020. Uwa pwan pesei pwe ekkewe neni rese pachenong non ewe teten repwe fori annukun ewe mokutun towaw fesen non fansoun angang.

Non March 18, 2020, Uwa akaunoi asukun non-feufeun aramas non ekkewe sukkun mei watte tori April 28, 2020.

Non March 22, 2020, Uwa tungor esapw wor atou aramas me non imw ika rese moni imwer, resapw apochokuna annukun kapung, resapw ngenir taropwen niwinimang, me met mei nom non tetenin moni imw.

Non March 23, 2020, Uwa uwau annuk pwe aramasen Orgeon repwe, "Stay Home, Save Lives," awenewen ngeni emon me emon epwe nom non imw, esipano ekkoch

sitowa, awora towaw nefinen aramas fansoun fori mettoch mei auchea, iwe epwe wor taropwen ekkewe mokutuk epwe fis nukun me non nenien tumun semirit.

Non April 1, 2020, Uwa tungor esapw wor atou aramas me non imw ika rese moni imwer anongonong won nour kewe taropwen etipew, pun ina ew anen ar repwe nom non imw usun mei auchea, me pwan awora ekkewe mettoch mei mwirino me aninis non ei fansoun osukosuk mei weiweita.

Non April 8, 2020, Uwa esinesin pwe sukun epwe kesip me auwenoi asukun non feufeun-aramas non ekkewe sukkun watte epwe sopouloso tori muchun ei ierin sukun.

COVID-19 mei tongeni epwe angawa ngasangas mine ewe emon epwe chouno an semwen ika fen mano. Ewe Putain World Health Organization a esinesin pwe COVID-19 a ew semwen non unusen fonufan. COVID-19 a fetan seni emon-nge-emon aramas nupwen a mwor, mwesi, me marengeni emon, mei pachenong atap fetan ia ewe virus mei nomw ie me atapa awom, potum, ika mesom.

Chon angang ngeni State me local public health ra esinesin pwe ewe virus mei nom fetan non community iwe chomong epwe torir ei semwen. Ewe United States Centers ren Disease Control me Prevention (CDC) a repotei pwe COVID-19 mei fakkun efeiangaw nupwen emon epwe mefi ekkewe esisin, nge mei tongeni epwe ngeni emon me mwen epwe mefi ekkewe esisin. CDC a pesei ekkoch mokutukut an epwe epeti cheunon ewe semwen non community, pachenong annukano ekkewe pekin chufengen me mwich.

Mei napenon ekkewe a torir COVID-19 mei chomongono me non Oregon. Non March 8, 2020, non ewe fansoun uwa apungano pwe sia nom non atapwanapwan, a fen wor 14 case a punguno me non Oregon. Iwe ren ikenai, a ukkukun 1,785 a torir ei semwen me 70 ra mano.

Non ei mochomochen fansoun, COVID-19 mei mwitir cheufetan. An epwe kisikisino ei COVID-19 non Oregon, me tumunu nonomun me manawan aramasen Oregon, akaewin ekkewe mei apwangapwang, Uwa mefi pwe ach angang epwe mwitir ach sipwe fori annukun met epwe tumunu manawan, nonomun, me tufichin aramasen Oregon.

Ewe COVID-19 mei atapwanapwan a chomong mei tou seni angang me weires moni tonong ngeni chomong aramasen Oregon.

Mei wor aramasen Oregon mei kuu ewe aninis seni CARES Act Recovery Rebate epwe kamou. Faniten ewe ORS 433.441, ORS 401.168, ORS 401.175, ORS 401.188, me ORS 401.192, Ua otura me opwungano ekei pwopwun porous, faniten an epwe tutumwunu ewe CARES Act Recovery Rebate aninis ngeni emon me emon. A for ekkei faniten chochon non Oregon are repwe tongeni nounou ekkei pekin aninisin kamotiw faniten imwer, ener, met aninisir ren non pioing me metekewe mei kon auchea epwe wor rer non ei atun weiweitan osukosuken COVID-19.

1. Awewe.
 - a. “COVID-19 emergency period” a wewe ngeni ei fansoun weiweitan atapwanapwanen osukosuk faniten COVID-19 a kopwunguno me katou non an Kepina E nukunukuk Nampa 20-03 iei mei pwichipwich, mei pwan kapachenong pwan met sopwosopwun ei fansoun weiweitan me atapwanapwanen osukosuk.
 - b. “Financial institution” mei chok pwan wewengeni met a fen kawor me non ewe ORS 18.600(7).
 - c. “CARES Act” a wewe ngeni ika kapas faniten “Coronavirus Aid, Relief, and Economic Security Act” (H.R. 748) mei kopwunguno seni ewe United States Congress me saiin meren ewe President noun United States non ewe March 27, 2020.
 - d. “Recovery Rebates” a wewe ngeni met mei kamouu ngeni akaemon aramas mei mwumwuta an epwe nounou seni ewe mwuun United States esapw napeseni \$1,200 emon (ika \$2,400 ren ekkewe re file ar joint return), kapach \$500 ngeni emon semirit mei mwumwuta epwe pwan nounou, fan nurun Sec. 2201(a) ren ewe CARES Act.

2. Aninis mei katou fan CARES Act Recovery Rebates Prohibited. Faniten ei fansoun weiweita me atapwanapanen osukosuk ren COVID-19:
 - a. Meinin CARES Act Recovery Rebates ngeni akaemon aramas mei tongeni esapw pwon fan "garnishment" faniten enan kapas mei afatetiw non ORS 18.602 me aean fan ORS Chapter 18, menukun an noun Kepina we Esinesin ika eureur mei kawor me katou non ei E nukunuk noun Kepina.

- b. Meinin CARES Act Recovery Rebates mei ketiweu ika rese pwon faan ekkewe mwonien aninis fan nurun noun Kepina ei Eureur me metekewe sokkun aninis epwe ketiweno nupwen a wor kaworen senis ngeni an emon nenien isois senis non ekan bank, non ewe eew chok napanap faniten ekkoch kaworen senis mei afaat fan ORS 18.348(3).
 - c. Nupwen epwe tour ika wor noun emon ewe Notice or Writ of Garnishment, meinin ekkewe bank re isois senis repwe fori ar angang faniten CARES Act Recovery Rebates usun chok met ir mei fofor ngeni ekkewe aninis mei tou seni federal faniten ar repwe fiti onukun me wiser fan ewe ORS 18.784, me nukun ika ewe pekin aninis ren senis e era pwe: "Ei Aninis Non Pekin Senis A Katou Faniten Epwe Angei eew Criminal Money Judgment mei Ewina Aninis ika eew Pwungun Kopwung faniten Civil faniten eew Criminal Offense." Nupwen kopwe ponuweni ei sokkun aninis non senis mei porous faniten ewe wewe mei afaat asan, ewe nenien isois senis ika bank epwe fori an angang faniten Recovery Rebate nge epwe fiti ngeni garnishment.
3. Eureur. Ewe Attorney General me ewe Putain Justice an Oregon epwe awora an aninis me eurer faniten ekkei wewe mei afat non noun Kepina ei Eureur, ika pwe mei auchea me namwot.
4. Ketiwenon. Notwithstanding paragraph 2 non noun Kepina ewe Eureur:
 - a. CARES Act Recovery Rebates epwe nomw fan nurun met sokkun aninis non senis mei katou ar repwe ioni faniten ei wewe: (a)

pwungunon kopwung non eew criminal action pwe ewe chon tipis epwe moni paking; or (b) non pwungunon kopwung faniten civil judgment pwe emon mei angei chapen an tipis ren eew criminal offense, mei afat pwe epwe wor chapen tipis faniten ekkewe pwopwun mei afat non chapen tipis.

- b. Pekin aninis non senis mei afat non ewe paragraph 4(a) an Kepina Eureur epwe afata ei pwopwun me wewe pwe: “Ei Aninisin Senis Mei Katou Faniten Chapen Tipis faniten Criminal Money Judgment mei Awora Kamotiwen Chapen Tipis ika eew Pwungun Kopwung Faniten Civil faniten eew Criminal Offense.”
- c. Mei kapachenong ngeni ei pwungun kopwung mei afat non paragraph 4(a) ren Noun Kepina Ei Eureur, ewe Attorney General epwe afata met pwungun kopwung faniten chapen tipis epwe ioni seni ewe Aninis non senis mei katou ren CARES Act Recovery Rebates, non ei eureur mei katou me afat non paragraph 3 non Noun Kepina ei Eureur.
