Ourour ren Suksefan non Unusen ei State – Organization ren Pekin Urumwoten Nukun

Pochokunen Nemenem: Otutun Nampa. 20-27, ORS 433.441, ORS 433.443, ORS 431A.010

Pwonuetan: Ei kapasen ourour fan iten ekkewe Organization ren Pekin Urumwoten Nukun.

Angangen Apochokuna: Ngeni an epwe tufich ei ourour mei menei an epwe nomw fan nurun pwan ekkoch sokkun onnuk, an epwe tufich wor pochokunan usun mei affat non ewe Otutun 20-27, teten 26.

- Ren an epwene suksefan mwirin nangetamen kesipin ekkewe neni, iwe repwe akom pii pwe mettoch meinisin epwe mwirino non ekkewe park me imwen kukunou, epwe nukunukeoch usun met mei mak non ekkewe tetenin annuk ren aean ekkei neni.
- Ese mumuta mwicheich (ew mwich epwe 10 aramas ika kisiseni repwe tori ewe neni) ar repwe namotam ne nomofengen non ewe parking lot nge epwe wor wewechun ar nom ikewe/niwin sefan me tonong/tou seni war chitosa.
- Apochokuna auchean me aiti me makei won ekkewe sain an aramas repwe fori ewe onu (6) fiit nefinen emon me emon (ew mwich epwe 10 ika kisiseni repwe tori ewe neni) fansoun tota won chuuk, nom won pii me nenien mota.
- Ekkewe neni mi chommong emwicheichen aramas ie repwe kesip (pachenong nenien urumwot, nenien/imwen kukunow, nenien tukken, me ekkewe nenien urumwot usun basketball).

- Nimeti me aea pisekin nimenim ngeni ekkewe neni, chomong-ir mei tori, me iakewe chomong ir mei atapa me non public me esapw-public non park me neni.
- Pacheta [sain epwe fat](#) (mi nom won healthoregon.org/coronavirus) tettenin esisinen COVID-19, tingorei chon angang, volunteer me chon visit repwe nomw non imwer pwan ién repwe kokkori epwe anisir ika mei wor esisinen semwen rer.

- Fori kokot pwe ekkewe neni mei suk ngeni meinisin ren nenien picnic mei wor chepen ie esapw non imw/neni, imw mei suk iteiten raan, me imw mei suk pwe epwe wor ewe fororun onu (6) fiit nefinen aramas me ekkewe pisek ir mei aea (sea, nenien mwot, chepen). - Esipano ekkoch ekkewe parking lot non ekkewe neni pwe aramas repwe awora onu (6) fiit nefiner me non ekkewe neni.
- Fori epwe chok ew nenien fetan ren ekkewe annen won chuuk pwe aramas resapw kanefengen atun fetan. Awora ew-chok annen fetan an epwe mecheres ne kuna.
- Pesei aramas repwe kunou non park me neni fansoun esapw chomong mei feito me ese met epwe fis non ekkewe neni ika ese wor esinesin seni ekkewe neni.
- Pesei aramas repwe kunou non park me neni mei kanengeni imwer, auku sai nepwin me sa ngeni neni mei towaw seni nenier ren pekin kunou. Akaewin esinesin ngeni aramas resapw no ekis nukun nenier kewe ikewe mei watte COVID-19 case ie pwe epwe pwan epeti an esapw uwei monun COVID-19 seni emon mei positive ngeni ewe neni ese watte ewe virus ie me ese chomong case ie.
