## Kapasen Ourour ren Oruwen Kinikinin Suuksefan — Kafie, Bar, Nenien Forun Sakaw, Nenien Forun Wine, Rumwen neni ekkewe sakaw me wine mei for, me ekkewe Distilleries

**Pochokunen Nemenem:** Otutun Nampa. 20-27, ORS 433.441, ORS 433.443, ORS 431A.010

**Pwonuwetan:** Ei ourour fan iten ekkewe nenien mongo, bar, nenien for sakaw, nenien for wine, rumwen neni ekkewe sakaw me wine mei for, ekkewe distillery non ekkewe sopw ra nomw non kinikinin Phase Ruw.

**Angangen Apochokuna:** Ngeni an epwe tufich ei ourour mei menei an epwe nomw fan nurun pwan ekkoch sokkun onnuk, an epwe tufich wor pochokunan usun mei affat non ewe Otutun 20-27, teten 26.

### Towaw fesen me Chochon:

#### Nenien sopai repwe:

- Nengeni sefani me Anganga [Unusochun Kapasen Ourour ngeni ekkewe Nenien Angang](#).
- Eukuku ukukun chochon aramas non ew neni ngeni 100 aramas chochon repwe nomw non ika 250 aramas ren chochon repwe nomw nukun, esapw nap seni 250 chon nomw non me nukun; ika ewe ukukun aramas, mei pachenong chon angang, anongonong won ukukun aramas repwe tongeni nomw non ewe neni (square fit/chochon), ika ifan kookun an epwe chokukun.
- Fori pwe ekkewe chepen epwe ukukun onuw (6) fit towawen nefiner pwe epwe tongeni pwonueta ewe ukukun onuw (6) fit nefinen fitu kinikinin mwicheich, pwan pachenong nupwen ekkewe customer repwe no ngeni ika no seni ekkewe chepen.
  - Ekkewe nenien sopai repwe fori tetenin nenien mot non ewe neni epwe tongeni fiti ngeni ewe ururun kookun towawen nefinen emon me emon. Ika pwe epwe tufich, ekkewe nenien sopai repwe mutata an epwe tongeni kanapeno ukukun nenien ipweipwen emon me emon me nukun ekkewe neni ren an epwe tongeni pwonueta ewe kookun onuw (6) fit towawen nefinen emon seni emon.
  - Omwokutu ika euku nenien momot fan iten ponuwetan ewe onuw (6) fit towawen nefien aramas esapw ir chon ew mwich.

- Ika pwe ekkewe nenien momot ir mei back-to-back, iwe epwe ew ekkewe nien mot epwe tongeni an epwe masow ew esapw masow, me nukun chok ika pwe mei wor met epwe refi feseni nefiner usun met mei affat non ei kapasen ourour me fan.
- Euku chochon ew mwich ngeni 10 arams ika fen kukun seni. Non ekkewe neni ir mei aea fengen nenien momot, kosapw ochufengeni chon mwicheich/chon chuuto ika pwe rese finata pwe repwe chok chufengen. Iokewe chon ew mwich ir mei nomw fengen ren efoch chepen ese pwan menei ar repwe momot onuw (6) fit towaw fesenin nefiner.
- Ika pwe ew nenien sopai ese tongeni an epwe fori ewe ukukun onuw (6) fit towawen nefinen aramas, me nukun chok ekis fansoun ar repwe angeifengen (awewe ren, atourano mongo ngeni chepen), iwe epwe chok fori angangen an iwe neni won an epwe chok nenien eto pick up/to go. Ei ngeni ir me ruw ekkewe nenien momot non me nukun.

### **Nenien sopai repwe:**

- Pacheta kinas plastic mei kurufat (ekewe kinas plastic mei sakopat onuw) ika pwan ekkoch sokkun eppet epwe mecheres an epwe nimenim, an epwe refifeseni nefinen ekkewe nenien momot pwe siwinin ewe onuw (6) fit towawen nefinen aramas, ika pwe ewe kinikinin nefinen ekkewe nenien momot epwe tongeni ew (1) fit tekian seni asen mokuren ion kastomer mei mommot me pwan ukukun unungat (3) fit cheen ika pwe ewe nenien momot mei chewatte seni unungat (3) fit.

### **Chon angang:**

#### **Nenien sopai repwe:**

- Eukuku an nour chon angang repwe angengeni mongo won ekkewe chuun mongo nge pour ese poupou.
- Apochokuna angangen nimetochu paw (iteitan me pungun totonun paw) mi fokkun namot ngeni meinisin chon angang, pachenong ekkewe chef, kuk, me chon wisen sapis mongo.
- Fori pwe chon angang repwe poupou glove nupwen repwe fori angangen nimenim, ika enimenima nimengawen monun paikin. Kose mochen makketiw pwe ren met angang esapw angangen enimenim, ew neni ese wor noun licence meren ewe Oregon Department of Agriculture (ODA) ese pwan menei ar repwe poupou glove. Poupou glove ren angang mei fiti angangen mongo mei tongeni pwe epwe angawano ekkewe mongo. Ika pwe ew nenien sopaie finata pwe noun chon angang repwe poupou glove, iwe repwe awora ekkewe non-latex glove me ekkewe chon angang repwe fori an esapw wor ar repwe angawano ekkewe mongo ren ar repwe ekkesiwini pour kewe glove me murin ar atapeta won meser ika fen pwan ar siwini met re ani angang (awewe ren, amonata mongo murin chok ra wau kapich nukun). - Esapw mumuta ngeni nour chon angang ar repwe angengeni mongo won pour nge rese poupou usun met mei nomw non nour we taropwen license.

## **Angangan:**

### **Nenien sopai repwe:**

- Fiti ngeni met mei nomw non ewe taropwen ourour, me pwan metekewe sokkun repwe fori me pwan sokkun onnukun ar angang ren fetanin ururun met angang repwe fori.
- Ekkewe nenien mongo me un pwan pachenong nenien un sakaw repwe kesipeno me kunok 10 nepwin. Ew nenien sopai epwe tongeni suk sefan non ewe ran sorotan anongonong won ururun kunokun an epwe suk nge esapw mwithir seni kunok 4 nesosor.
  - Ren ekkewe nenien mongo ir mei kan suk non ukukun 24 awa non ew ran non ei Oruwen Kinikinin Suksefan me non ekkewe kukun sopw, resapw suk me mwen kunok 4 nesosor pwokiten repwe fori angangen enimenimen non ewe nenien mongo an epwe fiti met masowen an OHA Kapasen Ourour.
- Esapw mumuta self-service ngeni kastomer, pachenong ekkewe buffet, nenien salad bar, ekkewe mwesinen soda me pwan ekkewe nenien omw kopwe anonouw unumom minen uun ian.
- Enimenima ekkewe metoch mei fis pwe kastomer rekan soun attapa me ren ekkewe chepenin mongo iteiten murin an kastomer/chon eto mongo aea, pachenong ekkewe sea, chepen, menu, ekkewe kukun nenien son me suke won chepen, me pwan ekkoch metoch ir mei tongeni ar repwe attapa.
- Awora ekkewe kukun nenien nofitin mongo ren, son me pepper, ketchup, hot sauce me suke, non tukutuk repwe tongeni chok aea fan ew. Ika pwe esapw tongeni tufich ena, iwe ekkewe kukun nenien masowen won chepen resapw totiwon chepen me mwen an epwe wor chon aea iwe epwe pwan enimenim iteiten nefinen an kastomer ika chon eto mongo aea. Angangen enimenimen monun nimengaw epwe fis non nikinikin an esapw angawano ekkewe mongo. Awewe, esapw wor aea ekkewe minen enimenim spray won ekan nenien son sikan wichikichiki.
- Esapw awesitiwon chepen met pisekin mongo me mwen an epwe wor chon aea (napkin, fok me sipun, kapekinas).
- Esapw mumuta momot ren counter ika ren bar me nukun chok ika ewe countr mei sapengeni ewe asamwacho ika etiiip me epwe tongeni ukukun onuw (6) fit towawen nefinen chon ew mwicheich me/ika chon angang ren ewe bar. Ei epwe ngeni ekkewe neni meinisin pachenong ekkewe bar, nenien forun sakaw me pwan ekkewe rumwen neni ekkewe sakaw me wine mei for. Ika pwe ekkewe neni re kuna pwe an kastomer repwe order me ren ekkewe counter me bar epwe ekisano an chon angang resapw mecheres ne torir menuun ewe samwau iwe mei mumuta. Ika pwe repwe order me ren counter iwe chon angang repwe atoura ener kewe mongo me unumer sakaw ngeni ar kewe chepen pun epwe tongeni ponueta ewe angangen atowawa nefinen aramas non ukukun onuw (6) fit ren nefinen kastomer me chon angang nupwen fansoun repwe order me non ekkewe nenien mongo me un.

- Fori pwe ekkwe kastomer/chon ew mwicheich erpwe ukukun onuw (6) fit towawfesenin nefiner nupwen repwe wanong ar order.
  - Epwe wor sain epwe pacheta pwe ekkewe kastomer repwe kuna me fori metekewe kapasen ourour mei menei pwe repwe fori.
  - Esisina won ekkewe simen ian emon me emon kastomer repwe uta ian nupwen repwe utiwit non nain.
- Fansoun meinisin enimenima ekkewe nenien an kastomer nonomw me ian rekan attapeta ian, pachenong ekkewe mwesinen kamotiw.
- Nounou menu epwe chok nounoun fan ew chok, epwe tongeni ar repwe enimenima (epwe laminate), online, ika fen makketa won ekkewe nenien mak mei pwechepwech ika met epwe tongeni ar repwe kuna mak won pwe an esapw wor an chommong repwe attapa.
- Ren ekkewe nenien etiki rekoto sikan etikanong foun moni non, epwe chok nonopok ne fiti met ekkewe Video Lottery Terminal ir mei fori iei mei affat me fan.

**Ngeni ukukun an epwe tufich, ekkewe nenien sopai repwe, nge ese pwan menei pwe repwe fori:**

- Awora ion epwe wisen etiwonong ika fori angangen fetanin kastomer ar repwe tonong me tou ren an epwe tongeni pwonueta ewe koukun towawen nefinen aramas nupwen fansoun ar utiwit non nain, fansoun order, me nupwe fansoun ar tonong ika tou seni ewe neni. Kosapw epeti nenien tou fansoun kar.
- Eukuku fitemon chon angang repwe wisen fori angangen aninis ngeni chon ew mwicheich. Anomwu non kokkot pwe emon chon angang epwe anisi chon ew mwicheich epwe chok inaii tori fansoun wesinon kaworen aninis ngenir (sapis, nimetano met sepi mei nimengaw seni ewe chepen, kamotiw). Emon chon angang mei tongeni anisi fitu mwicheich nge epwe fokkun tonuechu poun ika aea sanitizer (epwe wor 60-95% arukor non) iteiten nefinen an awora angengen aninis ngeni fituw mwicheich.
- Awora chon angang epwe wisen nenengeni fetanin kastomer me non ekkewe neni ir mei soun no ngeni ian ren imwen ngaseno pun esapw wor ar repwe iechufengen non ew neni.
- Pessei ngeni kastomer ar repwe awesi ne kokonong me mwen ewe fansoun ar repwe eto ngeni ewe neni pwe epwe fat ar repwe enenia ngenir nenier/fitemon chochon. Awora ew anen kokonong won fon epwe tongeni anisi ngeni aramas ar repwe utiwit non nain nefon war kewe chitosa me repwe tongeni tonong nupwen awor koko ngenir ika text ika nupwen noun ewe nenien mongo iwe "mwesinen esinesin" epwe ne okurang an epwe affata ngenir pwe a wor chepen a monneta.
- Ekiki ne awora nenien totonun paw fan iten kastomer ar repwe tonu pour ren non me arun ewe nenien sopai. Ekkewe hand sanitizer mei och ne aea ngeni paw mei nimenimoch. Ekkewe nenien sopai repwe awora hand sanitizer (epwe wor 60-95% arukor non) fan iten ekkewe kastomer. Hand sanitizer esapw ekkesiwini totonun paw ngeni chon angang.
- Pacheta sain epwe fat (mei nomw won ewe [healthoregon.org/coronavirus](http://healthoregon.org/coronavirus)) tetenin ekkewe esisinen COVID-19, aiti ngeni chon angang me kastomer ion mei wor rer ekkewe esisinen ewe samwaau ar repwe nom neimw, me aiti ngenir io repwe kori pwe epwe anisir.

## Nenien sopai repwe:

Pacheta ekkewe kinas plastic mei kurufat (ekewe kinas plastic mei sakopat onuwan) ika pwan ekkoch sokkun eppet epwe pwan mecheres an epwe enimenim, nefinen ewe counter me ekkewe nenien momot ren ewe bar an epwe siwini ewe onuw (6) fit towawen nefinen aramas, ika pwe ewe kinikinin nefinen ewe counter me ekkewe nenien momot epwe tongeni ew (1) fit tekian seni asen mokuren ion kastomer mei mommot me pwan ukukun unungat (3) fit cheen ika pwe ewe kinikinin nenien momot mei chewatte seni unungat (3) fit.

## Angangen ekkewe Video Lottery Terminals (VLT):

### Nenien sopai repwe:

- Enesia ekkewe VLT ar repwe ukukun onuw (6) fit towawen nefiner, ika pwe mei tongeni ar repwe enenier non ena koukun. Ika pwe esapw tufich ewe koukun onuw (6) fit towawen nefiner ekkewe mwesinen VLT, ekkewe nenien sopai repwe pacheta ekkewe kinas plastic mei kurufat (ekewe kinas plastic mei sakopat onuwan) ika pwan ekkoch sokkun eppet epwe pwan mecheres an epwe enimenim, nefinen ekkewe mwesinen VLT an epwe siwini ewe onuw (6) fit towawen nefiner, ika pwe ewe kinikinin ekkewe mwesin epwe tongeni ew (1) fit tekian seni asen mokuren ion kastomer mei mommot me pwan ukukun unungat (3) fit cheen ika pwe chechen ewe nenien VLT mei napeseni ukukun unungat (3) fit.
- Fori pwe chon repwe nounou ekkewe VLT repwe angei mumutan meren chon angang; ewe chon angang epwe akkoum enimenima ewe mwesin me mwen epwe mumuta an emon epwe nounou. Ewe nenien sopai esapw mutata an emon epwe nounou ekkewe VLT ika pwe ese akkoum angei mumutan meren ewe chon angangen ewe neni.
- Ekieki pwe emon chon nounou ekkewe mwesinen VLT mi nonongeni chok emon kastomer mei mommot orun ew chepen ren an emon epwe anisi.
- Eukuku an epwe chok emon chon nounou ika nomw orun ewe VLT.
