Ekkei ponuwen kapas ais FAQs repwe mwitir for sefan nupwen epwe wor met epwe ekkesiwin. Ekkei ponuwen kapas ais FAQs resapw siwini ewe eureur, nge repwe fen awewei, awora me anisi met tichikin ewe eureur.

## **Q1: Kose mochen ngeni kich wewen ika eureuren met wewen ei fos 'civic gathering'?**

**A1:** Ew civic gathering ew mwichen aramas ra chufengen ar repwe porous won ew osukosuk fan iten unusen aramas, ren chon ewe board seni sukun ika an ewe town hall mwich.

## **Q2: Ika ew neni mi wor minen non me nukun, met mei tongeni epwe wor emwicheich seni fitu mwich non me nukun nge epwe pwan tori ewe keukun chochon aramas ren ew me ew mwich?**

**A2:** Ewe koukun chochon non ew neni mei pwan men ngeni ekkewe kinikinin ika pwe:

- ekkewe chon fiti ekkewe fitu mwicheich rese chufengen, pachenong rese aea fengen imwen ngaseno; *me*
- pwan imwuno nenien tonong me tou ren ew me ew mwich.

## **Q3: Met eureuren fiti mwichen ungeni annuk?**

**A3:** Ungeni annuk ew pekin civic gatherings iwe epwe fiti ewe keukun chochon mwich mei afat non ewe Phase ewe county e nom non.

## **Q4: Met eureuren nenien fetan nukun ikewe an mwichen aramas nenien fetan ngeni ew me ew sopai?**

**A4:** Fansoun fiti ewe mwichen fetan, chon fetan repwe fiti an [Unusen State Chufengen, Ren Eureuren Chufengen Ren-Kukunou Non Imw](#). Ika chon fiti ewe mwich re tonong non ewe sopai mei fiti an OHA eureur (awewe, kafie ika kukkun sitowa), repwe pwan fiti ekkewe eureur mei weneiti ewe sopai.

**Q5: Ewe kaukun ekkewe emwicheich ngeni 50 aramas non imw me 50 aramas nukun epwe 50 kapachanapan?**

A5: Ika ru emwicheich mi imufesen ra fis fan ew chok, ew non me ew nukun, ew me ew ekkewe emwicheich mi tongeni or 50 aramas non. Ekkewe chon fiti ekewe emwicheich mi imufesen resapw wor ar repwe chufengen me ewe ew, pachenong resapw aea fengen imwen ngaseno me repwe aea nenien tonong me tou epwe imufesen.

Ika mei wor amokut epwe fis non me nukun ewe neni ika imw, iwe esapw nap seni 50 aramas repwe nom non ekkewe kinikin ren non ekkewe kunokun chufengen.

**Q6: Ifa kaukun emwicheich won somá?**

A6: Non Phase Ew, ewe kaukun me asan ren emwicheich iwe 50 aramas non, 50 aramas nukun. Non Phase Ruu, ewe kaukun me asan ren emwicheich iwe 50 aramas non, 100 aramas nukun. Non Phase Ruu, ika mei wor iotekin soma non ewe neni (me wor mongo mei kawor, non ew neni aramas repwe aea fengen, pwan ekkoch), iwe ewe Phase Ruu Eureuren Neni me Amokut epwe ponuweta (epwe ukkukun 100 aramas non me 250 aramas nukun, nge esapw nap seni 250).

**Q7: Neni non Phase Ruu mei mutata 100 aramas non ika 250 aramas nukun, nge epwe pwan fiti annukun Chufengen, ewe epwe ukkukun 50 aramas non ika 100 aramas nukun. Kose mochen afata?**

**Q11: Met sokkun eureur ngeni ekkei sokkun mwich ren pekin aier sefan (awewe ren, Alcoholics Anonymous) repwe fiti non Phase Ew me Phase Ruu?**
