Q1: 1. Met ewe Angei Omw Opposun Eppet Oregon epwe fori?

A1: Ewe minen Angei Om Opposun Eppet Oregon epwe tongeni anisuk ren omw kopwe kuna iokkan ir mei nomw fan nurun ekkei tetenin ar ateteni chon repwe angei. Iwe epwe pwan anisi ngonuk omw kopwe fori an epwe toruk esinesin won text ika email ika pwe ka ttufichin pwe kopwe angei me ren state. Ika pwe ka ururun pwe kopwe angei, ei mettoch epwe pwan anisuk omw kopwe kuta meni nenien wau oppos ika nenien oppos mei kan ngonuk.

A2: Iwe nge [Angei Omw Opposun Eppet Oregon](#) ese afatettiw ururun fansoun, en mei tongeni nounou omw kopwe kuna chon uwau ami kewe osukosuk meinisin pwe ngang. Sipwe ngonuk nampan ekkewe nenien oppos ika ar website, pun kopwe tongeni sinei ika fori inet fansoun kopwe angei omw opposun eppet meren pusin ewe neni.

Ika pwe en mei nonomw non Oregon iei me en mei nomw fan tetenin ekkewe ra tufichin repwene angei iwe en mei tongeni kopwe Angei omw Opposun Eppet me non Oregon.

Q3: Ifan usun ai upwe pwoywuta ne nounou ewe Angei Omw Opposun Eppet Oregon?

A3: Nupwen epwe tou pworousen ami oua tufichin angei ouse mochen no ngeni ewe getvaccinated.oregon.gov and click “Get Started.” Mei menei pwe kopwe cheki ika pwe ka tufichin kopwe ne angei me mwen kopwe sign up ngeni an epwe kan wor esinesin ngonuk, fori ew omw account, ika kuta neni chon wisen awora ewe opposun eppet. Ika pwe a fen wor omw account won ewe Angei Omw Opposun Eppet Oregon, tiki “Login” ina mei nomw non na pwokuku asan won peniemwan.

Q4: Ngang mei tongeni upwe sainei itei ren an epwe kan wor esinesin ngeniei ika fori ew ai account ren ewe Angei Omw Opposun Eppet Oregon nge usapw pwan cheki ika pwe uwa tufichin upwe angei?

A4: Apw. Kose mochen akkoumw cheki ika pwe ka tufichin kopw angei.
