Q1. Fan fitu ach sipwe nimet ekkewe pisekin urumot nukun?

Q3. Met ekkewe pekin urumot nukun mei fiti ekemis mei mumuta non Phase Ruu?

Chon fori ekkei mokutukut repwe akota an epwe keuk ukkukun chon tonong non ewe neni pwe meinisin repwe tongeni awora ukkukun onu (6) fiit towawen nefiner. Chon fori ekkei mokutukut repwe euku chochon chon chufengen epwe 250 aramas ika ukkukun pèèpèèn aramas, pachenong chon angang, onongonong won ukkukun watten ewe neni (square fiit/chochon), meni chok e kisikis.

Q4. Met mei mumuta epwe wor fair me non ekkewe phase?
