Non **March 1, 2021**, meinisin chon Oregon ra ier 65 ika nap seni ra tufichin angei opposun appetin COVID-19. Esapw mang seni **March 29**, aramas re nom nonimwen chinap mi kukun ar moni tonong, pachenong congregate nenien chinap me nenien chinap rese menei an emon tumun, ir mi tufich ngeni.

Mi nap seni 766,000 aramas non ei kumi, non ei fansoun ach atoura ngeni mi muuk ukukun 156,000 chon Oregon ier 70 me nap seni ra angei ewin opposun appet. Ena 31 percent me nein meinisin chinap ir mi tufich ngeni. Ukukun 45 percent ren aramas 80 ier ika nap seni ra angei opposun appet. 194,565 aramas 65 ier ika nap seni ra angei ewin oppos ren ewe opposun appetin COVID-19 (non ewe February 25th). Ena 1 me nein 4 chinap.
