Ilo Eprōl 8, 2020, ikar keeañ ke jenaaj kōmōñāñe an jikuuḷ ko ikkiil im kōn ad kabbōjrak emmakūtkūt in ekkatak armej-nān-armej ilo imōn jeḷāḷokjeḷ utiejḷok nān jemḷokin tōm eo academic im iiō in jikuuḷ eo kiiōkiiō.

COVID-19 emaroñ in kōmman nañinmej in menono ekauwōtata me enaaj bōlen wōnmaanḷok nān nañinmej ekauwōtata ak nān mej. Douluḷ kōn an Laḷ in Ājmuur (World Health Organization) eo ej watōke COVID-19 āinwōt juon nañinmej-nān-aolep ilo aolepan laḷ eo. COVID-19 ej ajeeded armej-nān-armej ilo aer pokpok im maje, keepaak doon, āinwōt ilo aer jibwe pā ak “shake hands,” jibwe juon men eo ak ioon im virus eo ej pād ioon, innām jibwe loñiōm, boḷim, ak mejem.

Emōj an wōpija in ājmuur lobwilej state im local rōjañ ke virus eo ej ito-itak ilo jukjukin pād eo im ke rej katmāne ke enaaj lōñḷok wōran keej ko. An United States Jikin bōk Kajoor Ioon im Bōbrae Nañinmej (Centers for Disease Control and Prevention (CDC)) eo ej ripooti ke eḷaptata an COVID-19 ajeeded ñe elōn an armej ro kakōḷḷe, ak ebar maroñ in ajeeded mokta jān an kakōḷḷe ko waḷok. CDC ej rōjañe kiltōn kōjjemḷok an nañinmej eo ajeeded ilo jukjukin pād eo, kōpooḷ ad kōjjemḷok emmakūtkūt ko im iien kakkobaba ko.

Wōran keej ko an COVID-19 ej etal wōt im wōnlōñḷok ilo Oregon. Ilo Maaj 8, 2020, ilo kar iien eo me ikar keeañ ke elōn idiñ, ekar lōñ 14 keej ko ilo Oregon me rej ḷōmḷak wōt ak emōj kaḷool ke elōn. Rainin, elōn ejjab iietḷok jān 1,785 keej ko im 70 me rekar mej.
