Kajjitōk ko Rekut raar jab kōmman ñan bōk jikin melele in kajiniet eo ak ñan jipañ ukok, kakoba melele, im kanne tipdik in melele ko an kein kajiniet eo.

Kōmadmōd ko

K1: Kōm maroñ ke karōke tebōļ ko maanļok? Āinwōt ad karōk tebōļ ko mokta enaaj kadikļok an wōr iien ñan an rijerbal im customer ro keepaak doon?

U1: Jaab. Kwōban karōke tebōļ ko maanļok ñan an men ko pād wōt ilo an ejeļok customer rej jijet. Ñe juon rijerbal ekōnaa karōke juon tebōļ ilo iien eo wot maanļok jān an kajijet juon doulul eo, elañne wāween in enaaj kōmman bwe en dikļok an rijerbal im customer ro emmakūtūtč ippan doon, innām emālim wāween in.

K2: Ilo imōn kōpojak, kōm aikuj ke juon rilale kōjām? Elañne aet, armej in en ke juon rijerbal full time?

U2: Ñan joñan aer maroñ, peeņej ko ren, bōtaab rejjab aikuj jitōne rijerbal eo/ro ñan lale an customer ro deļoņe ijoko im ekkā an armej pād ie āinwōt imōn kōpojak ñan loloodjake an customer ro jab kakkobaba. Peeņej ko rebarāinwōt maroñ kajutak kōjjeļā ko realikkar ñan kōkeememej an customer ro kōttoļok jān doon.

K3: Etke elōn juon awa in jab jambo ilo 10 awa boñ ñan county ko Alen 1 im ej pedped ion ta? Armej ro ilo tebōļ ko reaikuj ke kaņōj aer mōñā ilo 10 awa boñ ke ak aolep armej reaikuj diwōj mokta jān 10 awa boñ?

U3: Aolepan Imōn Mōñā ko reaikuj in kabōjrak aolep mōñā im idaa mokta jān 10 awa boñ. Peejnef kein reaikuj kilōk ñan armej ro iloḃwilej ilo ejja awa eo ijellōkun ñe rej kōmadmōde kein mōñā ko kijen armej rej bōki (take-out). Jemlōkin iien kajijet armej ej aikuj waḷok ñan loloodjake aer ḷoor kakien. Imōn mōñā eo enaaj lale wāween aer ḷoor ekkar ñan waan joñak in kōmadmōd eo an.

K4: Kōmij ke karreo kōn jerajko ak kōn juon iiōk in peroxide? Ej ke aikuj in kajoorḷok ilo jejjetin ijoko? Ewi ekkutkut in, kōn ta kein karreo im ñāāt eo kōmin karreo?

U4: Karreo ijoko mōñā ko rej pād ie ilowaan jikin kōmaat eo im “itulikin mweo” aikuj in kōmman ekkar ñan [Kakien ko an Kōjparok Mōñā OAR 333-150-0000](#). Ñan ijoko “imaan mweo,” emōj an Wōpij in Kōjparok Mejatoto an U.S. kōmālim jet kein karreo me rej jermal ñan jet virus ko rej āinwōt COVID-19. Aolep kein manman kij me rej jibadek kein joñak in repād [ijin](#).

Ejjab aolep kein manman kij emōj kōmālim ñan ioon ijoko mōñā ko rej pād ie im kwōn kwaḷ kōn dān im manman kij ilo aer ḷoor kōmeḷeḷe ko ilo kilin bato ak pakij eo. Pukot jikin me ej ba “manman kij” ioon kilin kein karreo me emōj kāālōt innām kōjermal towan iien eo eḷaptata im joñan iiōk eo ekajoortata (joñan kein manman kij ñan kāre ippān aebōj) ilo section in.

K5: Kein kwaḷkoḷ kōnno eo aō, ñe eh karreo kōn joñan eo ekkā, enaaj ke mane kij in COVID-19?

U5: Aet, elōñ tokjān kein kwaḷkoḷ kōnno ko rej jibadek kein joñak ko an kakōllein mōñā kiiōkiio ilo aer kōjermal jerajko ak joñan bwil eo eutieḷ ilo 160F ilo jikin kein ilik kōnno ko ñan manman kij.

K6: Armej rej ke aikuj in jijet ñan aer mōñā im idaa ijo imōn mōñā?

U6: Emālim madmōd jān counter eo ñan wōtar im/ak ebbōk mōñā. Eḷap an emmanḷok jijet im mōñā im idaa ñan jipañ ñaj loloodjake an aolep ḷoor kakien eo ñan an wor jiljino (6) ne ettoḷok jān doon.

K7: Maroñ ko kōn Ājmuur Lōbwilej ilo Bukwōn ko (LPHA) reaikuj ke kōmālim juon plan ñan bar peḷḷok eo an imōn mōñā eo mokta jān aer bar kōjejjet kūtien? Juon imōn mōñā ej ke aikuj kōmmane juon an plan ilo jeje? Renaaj ke kōmmane ak kakien juon peba in ḷoor ikijjien COVID-19 ñan kaḃool kōn an juon jikin ḷoor meḷeḷe in kajiniet eo an Governor eo ikijjien bar peḷḷok?

U7: Jaab. Ijoko reaikuj ḷoor [meḷeḷe in kajiniet eo an OHA](#) bōtaab rejjab aikuj kōmālim mokta jān LPHA ko ñan kōmman aer plan ilo jeje ak ebbōk peba ñan kaḃool aer ḷoor kakien ko.

K8: Imōn mōñā ko reaikuj kabōjrak aer leļok mōñā im dānnin kadek ilo ijoko ilo 10 awa boñ, ak nāāt eo emālim aer bar peļļok?

U8: Mōko imōn mōñā im baar ren peļļok ilo raan eo ālikin ekkar ñan awa ko rekkā aer schedule ñan peļļok kōn awa in peejne. Imōn mōñā ko ren jab kajjioñ tōprak kakien eo ñan kilōk ilo 10 awa boñ ilo aer bar peļļok ilo lukkuun boñ.

K9: Imōn kōpojak ko reaikuj ke karreo ñan manman kij ikōtaan iien an kajjojo customer kōjerbali mweo?

U9: Jaab. Imōn kōpojak ko reaikuj ikut aer karreo im manman kij im elaññe aikuj, bōtaab ejjab menin aikuj aer karreo ikōtaan iien an kajjojo customer kōjerbali.

K10: Ijoko āinwōt bowling alley ko me rej kōmadmōde mōñā ak rej leļok juon makūtkūt ekilōk iumwin Wōtar in Kōmman eo an Governor eo remaroñ ke bar peļļok jikin mōñā eo aer?

U10: Aaet. Elaññe mweo ej bar peļļok jikin mōñā eo wōt im ej ļoor [melele in kajiniet eo an OHA](#).

K11: Jikin madmōd ko im customer ro rej kōmadmōd ñan er make, āinwōt mabuñ “continental,” buffet, salad baar, Mongolian barbecue, jikin bar kanne lime m dān (growler ko im kola) im kein etteiñ yogurt ko rej ke mō wōt?

U11: Aaet. Riberbal ro wōt reaikuj in kanne mōñā im emō wōt madmōd ko im customer ro rej make kanne. Juon Mongolian barbecue emaroñ madmōd elaññe rijerbal ro rej kanne iik in mōñā ukood ko ñe juon customer ej kālōte mokta jān aer kōmaate. Emālim an customer ro kōmadmōde er make ijoko ilowaan imōn wia mōñā āinwōt mōñā ko likio im olive baar.

K12: Alen 1 bar peļļok eo ej ke koba baar ko, ruum in edjoñ, brew pub im wain bar ko?

U12: Alen 1 ej kōmālim an aolep imōn mōñā im idaaq peļļok . Bōtaab, armej reaikuj kabōjrak aer mōñā im idaaq ilowaan ijoko mokta jān 10 awa boñ.

K13: Rej ke bwini rijerbal ro ñan jemļokin wōran armej eļaptata im remaroñ pād ilowaan imōn mōñā im baar ko?

U13: Aaet, ej koba rijerbal ro ilo wōran armej ro eļaptata remaroñ pād ilowaan juon imōn mōñā im baar. Jemļokin wōran eļaptata ej 100 armej ilowaan em ak 250 armej inabōj, ak wōran armej ekkar ñan aer lale joñan eo eļaptata ñan ijo (jukweea ne/wōran armej), jabdewōt eo edikļok. Elaññe peejne ko rej madmōd ilowaan em im inabōj jimor, tarlepin wōran eļaptata eban lōñļok jān 250 armej, koba rijerbal ro.

K14: Ia eo jemaroñ ebbōk būttūk im kein irir ñan manman kij?

U14: Doulul eo an Iṃōn Mōñā im Kiki an Oregon (Restaurant & Lodging Association (ORLA)) ej kōjparoke juon [laajrakin](#) ri-wia kein karreo me eloñ ñan peejneḷ ko.

K15: Ia eo im jemaroñ loe mejele in kajiniet kōn ruuṃ in edjoñ ko?

U15: Kwōmaroñ loe aolep mejele in kajiniet an Iṃōn Mōñā/Baar/Iṃōn Kōṃṃan Pia/Ruuṃ in Edjoñ/Iṃōn Kōṃṃan Dān in Kadek ilo eḷja [peba](#) eo.

K16: Iṃōn ṃōñā ko reaikuḷ ke apply bwe ren bar peḷḷok?

U16: Jaab. County ko reaikuḷ in apply ñan aer eṃṃakūt ñan Alen 1. Ñe eṃōḷ kōmālim county eo pād ñan deḷoñe Alen 1, enaaj jako an ṃōko iṃōn ṃōñā aikuḷ in kōjjeṃḷok aer ṃadṃōd ñan take-out/bōkḷok. (Elaññe eṃōḷ an OLCC laiḷen eo aṃ likjab kōn aṃ kar jab kōḷḷāiki, kwōaikuj kōkāāle. Oregon Lottery enaaj barāinwōt aikuḷ etale mōḷin in VLT ko aṃ mokta jān aer bar jinōe.)

K17: Oktak ko ikōtaan napkin ko nuknuk linen im napkin ko peba. Koṃbani in nuknuk ko rej bōki nuknuk ko juon kōtaan ilo juon wiik. Ta eo rej rōjañ ñan kōjerbale?

U17: Kwōmaroñ kōjermal nuknuk napkin ko rerreo. Kwōn tiljek ilo aṃ lale wāween aṃ kōkoṃ nuknuk ko eṃōḷ kōjermal/ rettoonon. Nuknuk ko rettoon reaikuḷ kōkoṃ ilowaan juon pāāk būḷajtiik ak juon nien im ewōr meḷen.

K18: Elōñ ke kakien ko reoktak ñan ijoko im elōñ būrookraaṃ in ṃōñā ko aer me Oregon Ra in Kōddek eo an (Department of Agriculture (ODA)) ej kōjeḷjet kūtien ak an Oregon Maroñ kōn Ājmuur (Oregon Health Authority (OHA)) ej kōjeḷjet kūtien aer būrookraaṃ in ṃōñā?

U18: Enañin aolep iien oktak ko rej pād ilo aer kōjerbale tebukro. Eṃōḷ kakien tebukro ñan aolep ṃakūtḷkūt ko ikijien ṃōñā im eṃōḷ an ODA kakien. Mōko rej kakien iuṃwin OHA ren ḷoor [Peba in Mejele Mool #1 kōn Kakōḷḷe in Mōñā – Kadikḷok am Kōjermal Pā ñe Eḷjeḷok Kein Kalbubu](#).

K19: Kwōḷ ke rōjañ bwe kōnṃo in ṃōñā ko āinwōt jibuun ren lemlem ilowaan juon nuknuk napkin?

U19: Aet, men in ej juon men in kōṃṃan eṃṃan bōtaab ejañin kakien kake ñan iṃōn ṃōñā im idaak ko.

K20: Wōn eo enaaj eṃṃantata ñan keepaak ñan kajjitōk bwe en bar kaalikkar ikijien menin rōjañ?

U20: Kwōn leļok kajjitōk ko bwe kōmin kaalikkar meļeļe in kajiniet ko an state ñan covid19.reopening@dhsaha.state.or.us.

K21: Ekoba ke iṃōn ṃōñā ko an train in sushi im waan dim sum iuṃwin “ṃadṃōd ko customer ro rej make kōṃadṃōde” me eṃōj kōṃ iuṃwin Alen 1?

U21: Rej watōke juon sushi train āinwōt an customer make kōṃadṃōde im eṃō kōnke customer eo ej make ektak pileij jiddik ko rej pād ioon kein kōroṃloj eo.

Elaññe customer ro rej wōtar kijeer ṃōñā jān waan dim-sum ak rejjab make kōṃadṃōde, enaaj mālim iuṃwin [meļeļe in kajiniet eo an OHA](#). Ṣweo en kōṃṃane kiltōn kōjparok ṃōñā eo ioon waan ṃōñā eo jān an ettoonon ilo iien aer bōke ilowaan iṃōn ṃōñā eo.

K22: Enaaj ke wōr jejjetin meļeļe in kajiniet ñan iṃōn “peet im ṃabuñ” im iṃōn kiki ko reddik im rej peļļok ñan ri-lotok (ejejjet ikijjien jibwe ṃōñā)?

U22: Iṃōn kiki ko reaikuj ļoore [meļeļe in kajiniet eo an OHA](#) ilo aolepan aer kōṃadṃōde ṃōñā.

K23: Aer kōṃo adwōj jambo ālikin 10 awa boñ kōn ṃōñā im idaaṃ ijoko rej ke ñan iṃōn ṃōñā ak café ko ilowaan aujpitōl ak bar jikin kōjparok ājmuur?

U23: Jaab. Aer kōṃo ikijjien ṃōñā im idaaṃ ijoko ejjab ñan jikin ṃōñā ilo iṃōn kōjparok ājmuur (ekoba aujpitōl ko), jikin lale ajri, jikin jerbāl, ṃōko iṃōn kien, jikin uwaake idiñ, būrookraaṃ ko an jikuuļ, ak būrookraaṃ ko rej jipañ kōn jikin kiki im ṃōñā ñan armej ro reṃōjṃo.

K24: Jea nuknuk ak ṃōttan ko jet reaikuj ke ṃanṃan kij ikōtaan iien an customer ro kōjerbali?

U24: Jaab. Ejjelok kakien ñan ṃanṃan kij jān jea nuknuk ko ikōtaan iien an customer ro kōjerbali.

K25: Elōñ juon aō laijen ñan wiakake dān in kadek. Ia eo imaroñ loe meļeļe in kajiniet eo jān OLCC kōn bar peļļok?

U25: Kwōmaroñ loe peba eo kōn meļeļe ṃool an OLCC ikijjien bar peļļok [iijin](#).

K26: Ikōṃaan kōļapļok jikin peejneṃ eo aō ñan ijoko ļobwilej ak an peejneṃ im wiakake dān in kadek, ilo loloodjake an armej kōttoļok doon. Imaroñ ke kōṃṃane men in?

U26: Elōñ juon an OLCC ablikājōn ilo peba ñan kōļapļok ijoko jikūṃ. Kwōmaroñ loe peba in ablikājōn eo im kōṃmeļeļe ko [iijin](#).

K27: Ebar lōñ aō kajjitōk kōn COVID-19 ikijjien laijen in dān in kadek eo aō. Ia eo imaroñ loi uwaak ko?

U27: Elōñ juon an OLCC peba kōn mejeje mool, im ekkā aer kōkāāle mejeje ko kobban. Kwōmaroñ loe [ijin](#).

K28: Customer ro me rej ettōrloḵ kōn wa ko waer ñan bōk aikuj ko aer reaikuj ke ekkōṅak kein kalbubu turun māj?

U28: Aet, āinwōt kakien ilo [Mejele in Kajiniet eo ñan Aolepan State eo ikijjien Mask, Kein Bōbrae Turun Māj Kein Kalbubu Turun Māj](#), elaññe customer ro reban kōjparok aer pād jiljino (6) ne ettoḵok ikōtaan wa eo im wūntō eo an drive-thru eo reaikuj ekkōṅak kein kalbubu turun māj, mask ak kein bōbrae turun māj.

K29: Aer kōmḵ adwōj jambo ilo 10 awa boñ ej ke jermal ñan ṁōñā wot ilowaan ṁweo ke ak ñan bar ijoko drive-thru?

U29: Aer kōmḵ adwōj jambo ālikin 10 awa boñ ej jermal ñan ṁōñā ilowaan eṁ im inabōj wōt - ejjab ñan ijoko drive-thru.

K30: Doulul ko an Fraternal Lodge remaroñ ke ṁadṁōd ilo Alen 1?

U30: Doulul in Fraternal Lodge ko me rej ṁadṁōd iuṁwin juon laijen in iṁōn ṁōñā remaroñ kōṁadṁōde an armej ṁōñā im idaak ijoko county ko rej pād ilo Alen 1, elaññe rej loore mejeje in kajiniet eo an iṁōn ṁōñā.

Doulul in fraternal lodge ko eṁōj kōjekdoḵone jān laijen in iṁōn ṁōñā iuṁwin ORS 624.038 kōnke rej ṁadṁōd wot ilo aer leḵok kijen ro uwaan im rilotok ro aer wōt remaroñ leḵok bwe ren ṁōñā im idaak ijo ilo county ko eṁōj kōmālim ñan aer eṁṁakūt ñan Alen 1 elaññe rej loor mejeje in kajiniet eo ñan iṁōn ṁōñā.

Barāinwōt, ñe lodge ko renaaj kōṁṁan kweilok, rej aikuj loor Wōtar in Kōṁṁan 20-27 kōn kōmḵ ikijjien kakkobaba im mejeje in kajiniet eo an OHA (waan joñak, kōjparok aikuj eo ikijjien kōttoḵok doon, im men ko jet). Eṁō an lōñloḵ jān 25 armej me rej kakkobaba ilo Alen 1. OHA ej rōjañ ke doulul in fraternal lodge ko ren loṁṁak kōn men kein me rej loor ñe rej peek ñan bar peḷloḵ im joñan aer naaj ṁadṁōde:

- Elōñ doulul in fraternal lodge ko im elōñ uwaan me rej uwaan jarin armej reṁōjṁo (im ekoba ro rerūttoḵok jān 65 yiō ak elōñ juon aer nañinmej ekauwōtata me ej pād wōt). Meñe elōñ kajjioñ ko aṁ reṁṁantata ñan loor aolepan mejeje in kajiniet ko an OHA, ewōr wōt uwōta ilo aṁ loḵok juon doulul in fraternal lodge. Governor eo ekanooj in rōjañ bwe armej ro reṁōjṁo ren pād wōt ilo ṁōko iṁweir iuṁwin Alen 1.
- Kōnke elōñ jarin armej reṁōjṁo im eddoin loor mejeje in kajiniet eo an iṁōn ṁōñā (waan joñak, loloodjake an armej ro kōjparok aer ettoḵok jiljino (6) ne

jān doon, eļaptata ilo jabdewōt iien rej jijet ak pād wōt ilo juon jikin), enaaj bōlen eṃṃanļok an jet lodge ko kilōk wōt ilo tōre in ak leļok wōt kōṃadmōd rejemļok.

Kōttoļok im Wōran armej

U1: Elaṅṅe itulikin juon counter/baar ej pād kiiṅ eṃ ak wūntō, emālim jijet ie ṅe rej loloodjake aer ettoļok ejjab dikļok jān jiljino (6) ne ettoļok jān doon. Elaṅṅe elōṅ jabdewōt jikin epeļļok ikōtaan counter/baar eo im kiiṅ eṃ ak wūntō eo, eṃo jijet ie.

K2: Ewi wāween aṃ bwini “wōran armej eo eļaptata” ṅan jibadek meļeļe in kajiniet eo an Governor ikijjen bar peļļok?

U2: Meļeļe in kajiniet eo an OHA ṅan iṃōn ṃōṅā im baar ej kōnnaan ke peejneṅ ko reaikuṅ kōjjeṃļok wōran armej eļaptata ṅan 100 armej ilowaan eṃ ak 250 armej inabōj, im en jab lōṅļok jān 250 ilowaan eṃ im inabōj, ekoba rijerbal ro, ekkar ṅan aer bwini wōran armej eļaptata ṅan ijo (jukweea ne/wōran armej), jabdewōt eo edikļok.

K3: Deli ko im ijoko jikin jijet ṅan ṃōṅā ilo iṃōn wia reaikuṅ ke ļoor ejja meļeļe in kajiniet eo an OHA ṅan iṃōn ṃōṅā im baar ko?

U3: Aaet.

K4: Elaṅṅe eutieṅ likin juon jea booth, emālim ke an dikļok jān jiljino (6) ne ikōtaan doulul ko me rej ṃōṅā?

U4: Jaab. Customer ro im rejjab uwaan ejja doulul in ṃōṅā eo reaikuṅ loloodjake bwe en wor jiljino (6) ne ettoļok jān ro jet.

K5: Elaṅṅe juon iṃōn ṃōṅā ej kajutak plexiglass ak būļajtiik, ak bar juon kain kein bōbrae ikōtaan tebōļ ak mōjin in lottery ko, emaroṅ ke dikļok jān jiljino (6) ne aer ettoļok jān doon? Imaroṅ ke kajutak plexiglass iturin baar eo? Rej ke watōke men in āinwōt juon kiiṅ eṃ ak wūntō bwe en mālim an armej jijet iṃaan bar ṅe elōṅ jiljino ne ikōtaan customer ro?

U5: Jaab. Customer ro me rejjab uwaan juon wōt pade in ṃōṅā reaikuṅ loloodjake bwe en wōr jiljino (6) ne ettoļok jān ro jet. Aṃ kajutak kein bōbrae ko ilo juon jikin ṅan kōjepel customer ro jān doon ak jān rijerbal ro emaroṅ naaj kadikļok ak ukōte wāween an mejatoto eṃṃakūt im emaroṅ bōlen kōṃṃan an mejatoto jab kāāl.

K6: Kakien eo ṅan kōttoļok jiljino ne ej ke jerbal ṅan ijoko jikin jijet inabōj?

U6: Aaet. Jej aikuj in loloodjake an wōr jiljino (6) ne ettoḷok ikōtaan doulul ko jekdoḷon ñe rej jijet ilowaan em ak inabōj.

K7: Emālim ke ammem ebbōk doulul ko im elōñ 25 armej ilo juon ruuḡ in kwōjkwōj ñe ewōr jemḷokin 10 armej imaan juon tebōj?

U7: Jaab. Mejele in kajiniet eo an OHA ej kōnnaan ke jemḷokin doulul ko ej 10 armej ak ietḷok. Armej ro ilo juon wōt doulul im rej jijet ilo juon wōt tebōj rejjab aikuj in pād jiljino (6) ne ettoḷok jān doon.

K8: Juon imōn ḡōñā eaikuj kw kōjjemḷok an armej deḷoñe ijoko jikin kwaḷ pā, jikin rawūt, ak toilet ko ñan loloodjake an customer ro kōjparoke kakien ko ikijjien aer kōttoḷok jiljino?

U8: Jaab. bōtaab, ñan joñan aer maroñ, ijoko ren jitōñe juon/jet rijerbal ñan lale an customer ro deḷoñe ijoko rekkā, āinwōt imōn kōpojok ko ñan loloodjake ke customer ro ren jab kakkobaba.

K9: Kōn rilotok ro im rej jijet im kōmij kōḡadḡode inabōjin imōn ḡōñā eo, elōñ ke jabdewōt jemḷokin ḡweo ikijjien an rilotok ro jijet im ettoḷok jān doon?
