Ilo **Maj 1, 2021**, aoleb armij in Oregon 65 aer yiō im rūttolok renaj maroñ tōbrak in bōke wā in bōbrae eo an COVID-19. Ejab rumijlok jen **Maaj 29**, armij ro rej jokwe ilo imōn jokwe ko an rūtto an ro edik kōllā ko aer, ekoba jikin jokwe ko an rūtto kakobaba im iaer make, renaj maroñ tōbrak.

Elōñlok jen 766,000 armij ro ilo kumi in, ilo ien in rej lillab im lōllab ro ien aer wā im rej tarrin 156,000 armij in Oregon ro 70 aer yiō im rūttolok emōj aer bōk ejab diklok jen juon wā. Men in ej 31 bōjjāān in aoleb lillab im lōllab ro remaroñ tōbrak kiō.
